3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Protecting American
- 5 Goods and Services Act of 2005".

6 SEC. 2. PROHIBITION ON TRAFFICKING OF CERTAIN 7 GOODS AND SERVICES.

8 (a) IN GENERAL.—Section 2320 of title 18, United
9 States Code, is amended—

(1) by striking subsection (a) and inserting the
 following:

3 "(a)(1) Any person who intentionally traffics or at4 tempts to traffic in goods or services and knowingly uses
5 a counterfeit mark on or in connection with such goods
6 or services—

7 "(A) if an individual, shall be fined not more
8 than \$2,000,000, imprisoned not more than 10
9 years, or both; and

"(B) if a person other than an individual, shall
be fined not more than \$5,000,000.

12 "(2) Any person who possesses goods with a counter-13 feit mark with an intent to traffic such goods—

14 "(A) if an individual, shall be fined not more
15 that \$2,000,000, or imprisoned not more than 10
16 years, or both; and

17 "(B) if a person other than an individual, shall18 be fined not more than \$5,000,000.

19 "(3) In the case of an offense by a person under this
20 section that occurs after that person is convicted of an21 other offense under this section, the person—

"(A) if an individual, shall be fined not more
than \$5,000,000, imprisoned not more than 20
years, or both; and

1	"(B) if other than an individual, shall be fined
2	not more than \$15,000,000."; and
3	(2) in subsection (b), by striking paragraph (2)
4	and inserting the following:
5	"(2) the term 'traffic' means—
6	"(A) transport, transfer, or otherwise dis-
7	pose of, to another as consideration for any-
8	thing of value or without consideration; or
9	"(B) make or obtain control of with intent
10	to so transport, transfer, or dispose of; and".
11	(b) Prohibition of Transport of Counterfeit
12	Goods or Unauthorized Copies and Phonorecords
13	of Copyrighted Works.—
14	(1) IN GENERAL.—Chapter 113 of title 18,
15	United States Code, is amended by inserting after
16	section 2320 the following:
17	"§2320A. Transport of counterfeit goods and unau-
18	thorized copyrighted works into or out of
19	the United States
20	"(a) DEFINITIONS.—In this section—
21	((1) the terms 'copies' and 'phonorecords' have
22	the respective meanings given under section 101 of
23	title 17;
24	((2) the term 'counterfeit mark' has the mean-
25	ing given under section 2320(e)(1); and

"(3) the term 'United States' means each of the
 several States of the United States, the District of
 Columbia, and the territories and possessions of the
 United States.

5 "(b) OFFENSE.—Any person who intentionally trans-6 ports goods bearing a counterfeit mark or copies or 7 phonorecords of a copyrighted work not authorized by the 8 copyright holder into or out of the United States for the 9 purposes of commercial advantage or private financial 10 gain shall be fined not more than \$100,000, imprisoned 11 not more than 10 years, or both.".

12 (2) TECHNICAL AND CONFORMING AMEND-13 MENT.—The table of sections for chapter 113 of 14 title 18, United States Code, is amended by insert-15 ing after the item relating to section 2320 the fol-16 lowing:

"2320A. Transport of counterfeit goods and unauthorized copyrighted works into or out of the United States.".
