- 8 SEC. 3. AUTHORIZATION OF APPROPRIATIONS.
- 9 The Great Ape Conservation Act of 2000 is amended
- 10 by striking section 6 (16 U.S.C. 6305) and inserting the
- 11 following:
- 12 "SEC. 6. AUTHORIZATION OF APPROPRIATIONS.
- "There are authorized to be appropriated to the
- 14 Fund—
- 15 "(1) \$5,000,000 for each of fiscal years 2006
- and 2007; and
- 17 "(2) \$7,000,000 for each of fiscal years 2008
- 18 through 2010.".
