# A BILL

To establish the National Mormon Pioneer Heritage Area in the State of Utah, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Mormon Pio-
- 5 neer Mormon Pioneer National Heritage Area Act".

### 1 SEC. 2. FINDINGS AND PURPOSE.

2	(a) FINDINGS.—Congress finds that—
3	(1) the historical, cultural, and natural heritage
4	legacies of Mormon colonization and settlement are
5	nationally significant;
6	(2) in the area starting along the Highway 89
7	corridor at the Arizona border, passing through
8	Kane, Garfield, Piute, Sevier, Wayne, and Sanpete
9	Counties in the State of Utah, and terminating in
10	Fairview, Utah, there are a variety of heritage re-
11	sources that demonstrate—
12	(A) the colonization of the western United
13	States; and
14	(B) the expansion of the United States as
15	a major world power;
16	(3) the great relocation to the western United
17	States was facilitated by—
18	(A) the 1,400 mile trek from Illinois to the
19	Great Salt Lake by the Mormon pioneers; and
20	(B) the subsequent colonization effort in
21	Nevada, Utah, the southeast corner of Idaho,
22	the southwest corner of Wyoming, large areas
23	of southeastern Oregon, much of southern Cali-
24	fornia, and areas along the eastern border of
25	California;

1	(4) the 250-mile Highway 89 corridor from
2	Kanab to Fairview, Utah, contains some of the best
3	features of the Mormon colonization experience in
4	the United States;
5	(5) the landscape, architecture, traditions, be-
6	liefs, folk life, products, and events along Highway
7	89 convey the heritage of the pioneer settlement;
8	(6) the Boulder Loop, Capitol Reef National
9	Park, Zion National Park, Bryce Canyon National
10	Park, and the Highway 89 area convey the compel-
11	ling story of how early settlers—
12	(A) interacted with Native Americans; and
13	(B) established towns and cities in a
14	harsh, yet spectacular, natural environment;
15	(7) the colonization and settlement of the Mor-
16	mon settlers opened up vast amounts of natural re-
17	sources, including coal, uranium, silver, gold, and
18	copper;
19	(8) the Mormon colonization played a signifi-
20	cant role in the history and progress of the develop-
21	ment and settlement of the western United States;
22	and
23	(9) the artisans, crafters, innkeepers, outfitters,
24	historic landscape, customs, national parks, and ar-

1	chitecture in the Heritage Area make the Heritage
2	Area unique.
3	(b) Purpose.—The purpose of this Act is to estab
4	lish the Heritage Area to—
5	(1) foster a close working relationship with al
6	levels of government, the private sector, residents
7	business interests, and local communities in the
8	State;
9	(2) empower communities in the State to con
10	serve, preserve, and enhance the heritage of the
11	communities while strengthening future economic
12	opportunities;
13	(3) conserve, interpret, and develop the histor
14	ical, cultural, natural, and recreational resources
15	within the Heritage Area; and
16	(4) expand, foster, and develop heritage busi
17	nesses and products relating to the cultural heritage
18	of the Heritage Area.
19	SEC. 3. DEFINITIONS.
20	In this Act:
21	(1) ALLIANCE.—The term "Alliance" means
22	the Utah Heritage Highway 89 Alliance.
23	(2) Board.—The term "Board" means the
24	Board of Directors of the Alliance.

8	Alliance shall provide to the government of each city,
9	town, and county that has jurisdiction over property
10	proposed to be included in the Heritage Area written
11	notice of the proposed inclusion.
12	(c) Administration.—The Heritage Area shall be
13	administered in accordance with this Act.
14	SEC. 5. DESIGNATION OF ALLIANCE AS MANAGEMENT EN-
15	TITY.
16	(a) In General.—The Alliance shall be the manage-
17	ment entity for the Heritage Area.
18	(b) Federal Funding.—
19	(1) Authorization to receive funds.—The
20	Alliance may receive amounts made available to
21	carry out this Act.
22	(2) DISQUALIFICATION.—If a management plan
23	is not submitted to the Secretary as required under
24	section 6 within the time period specified in that sec-
25	tion, the Alliance may not receive Federal funding

- 1 under this Act until a management plan is sub-
- 2 mitted to the Secretary.
- 3 (c) Use of Federal Funds.—The Alliance may,
- 4 for the purposes of developing and implementing the man-
- 5 agement plan, use Federal funds made available under
- 6 this Act—
- 7 (1) to make grants and loans to the State, po-
- 8 litical subdivisions of the State, nonprofit organiza-
- 9 tions, and other persons;
- 10 (2) to enter into cooperative agreements with or
- provide technical assistance to the State, political
- subdivisions of the State, nonprofit organizations,
- and other organizations;
- 14 (3) to hire and compensate staff;
- 15 (4) to obtain funds from any source under any
- program or law requiring the recipient of funds to
- make a contribution in order to receive the funds;
- 18 and
- 19 (5) to contract for goods and services.
- 20 (d) Prohibition of Acquisition of Real Prop-
- 21 ERTY.—The Alliance may not use Federal funds received
- 22 under this Act to acquire real property or any interest in
- 23 real property.
- 24 SEC. 6. MANAGEMENT OF THE HERITAGE AREA.
- 25 (a) Heritage Area Management Plan.—

1	(1) Development and submission for re-
2	VIEW.—Not later than 3 years after the date of en-
3	actment of this Act, the Board, with public partici-
4	pation, shall develop and submit for review to the
5	Secretary a management plan for the Heritage Area.
6	(2) Contents.—The management plan shall—
7	(A) present comprehensive recommenda-
8	tions for the conservation, funding, manage-
9	ment, and development of the Heritage Area;
10	(B) take into consideration Federal, State,
11	county, and local plans in effect on the date of
12	enactment of this Act;
13	(C) involve residents, public agencies, and
14	private organizations in the Heritage Area;
15	(D) include a description of actions that
16	units of government and private organizations
17	are recommended to take to protect the re-
18	sources of the Heritage Area;
19	(E) specify existing and potential sources
20	of Federal and non-Federal funding for the
21	conservation, management, and development of
22	the Heritage Area; and
23	(F) include—
24	(i) an inventory of resources in the
25	Heritage Area that—

1	(I) includes a list of property in
2	the Heritage Area that should be con-
3	served, restored, managed, developed
4	or maintained because of the histor-
5	ical, cultural, or natural significance
6	of the property as the property relates
7	to the themes of the Heritage Area
8	and
9	(II) does not include any prop-
10	erty that is privately owned unless the
11	owner of the property consents in
12	writing to the inclusion;
13	(ii) a recommendation of policies for
14	resource management that consider the ap-
15	plication of appropriate land and water
16	management techniques, including policies
17	for the development of intergovernmental
18	cooperative agreements to manage the his-
19	torical, cultural, and natural resources and
20	recreational opportunities of the Heritage
21	Area in a manner that is consistent with
22	the support of appropriate and compatible
23	economic viability;

1	(iii) a program for implementation of
2	the management plan, including plans for
3	restoration and construction;
4	(iv) a description of any commitments
5	that have been made by persons interested
6	in management of the Heritage Area;
7	(v) an analysis of means by which
8	Federal, State, and local programs may
9	best be coordinated to promote the pur-
10	poses of this Act; and
11	(vi) an interpretive plan for the Herit-
12	age Area.
13	(3) Approval or disapproval of the man-
14	AGEMENT PLAN.—
15	(A) In General.—Not later than 180
16	days after submission of the management plan
17	by the Board, the Secretary shall approve or
18	disapprove the management plan.
19	(B) DISAPPROVAL AND REVISIONS.—
20	(i) In General.—If the Secretary
21	disapproves the management plan, the Sec-
22	retary shall—
23	(I) advise the Board, in writing,
24	of the reasons for the disapproval; and

1	(II) make recommendations for
2	revision of the management plan.
3	(ii) Approval or disapproval.—
4	The Secretary shall approve or disapprove
5	proposed revisions to the management plan
6	not later than 60 days after receipt of the
7	revisions from the Board.
8	(b) Priorities.—The Alliance shall give priority to
9	the implementation of actions, goals, and policies set forth
10	in the management plan, including—
11	(1) assisting units of government, regional plan-
12	ning organizations, and nonprofit organizations in—
13	(A) conserving the historical, cultural, and
14	natural resources of the Heritage Area;
15	(B) establishing and maintaining interpre-
16	tive exhibits in the Heritage Area;
17	(C) developing recreational opportunities in
18	the Heritage Area;
19	(D) increasing public awareness of and ap-
20	preciation for the historical, cultural, and nat-
21	ural resources of the Heritage Area;
22	(E) restoring historic buildings that are—
23	(i) located within the boundaries of
24	the Heritage Area; and

1	(ii) related to the theme of the Herit-
2	age Area; and
3	(F) ensuring that clear, consistent, and en-
4	vironmentally appropriate signs identifying ac-
5	cess points and sites of interest are put in place
6	throughout the Heritage Area; and
7	(2) consistent with the goals of the manage-
8	ment plan, encouraging economic viability in the af-
9	fected communities by appropriate means, including
10	encouraging and soliciting the development of herit-
11	age products.
12	(c) Consideration of Interests of Local
13	GROUPS.—In developing and implementing the manage-
14	ment plan, the Board shall consider the interests of di-
15	verse units of government, businesses, private property
16	owners, and nonprofit organizations in the Heritage Area.
17	(d) Public Meetings.—The Board shall conduct
18	public meetings at least annually regarding the implemen-
19	tation of the management plan.
20	(e) Annual Reports.—For any fiscal year in which
21	the Alliance receives Federal funds under this Act or in
22	which a loan made by the Alliance with Federal funds
23	under section 5(c)(1) is outstanding, the Alliance shall
24	submit to the Secretary an annual report that describes—
25	(1) the accomplishments of the Alliance:

1	(2) the expenses and income of the Alliance
2	and
3	(3) the entities to which the Alliance made any
4	loans or grants during the year for which the report
5	is made.
6	(f) Cooperation With Audits.—For any fiscal
7	year in which the Alliance receives Federal funds under
8	this Act or in which a loan made by the Alliance with Fed-
9	eral funds under section $5(c)(1)$ is outstanding, the Alli-
10	ance shall—
11	(1) make available for audit by Congress, the
12	Secretary, and appropriate units of government all
13	records and other information relating to the ex-
14	penditure of the Federal funds and any matching
15	funds; and
16	(2) require, with respect to all agreements au-
17	thorizing expenditure of the Federal funds by other
18	organizations, that the receiving organizations make
19	available for audit all records and other information
20	relating to the expenditure of the Federal funds.
21	(g) Delegation.—
22	(1) IN GENERAL.—The Alliance may delegate
23	the responsibilities and actions under this section for
24	each area identified in section $4(b)(1)$ .

1	(2) Review.—All delegated responsibilities and				
2	actions are subject to review and approval by the Al-				
3	liance.				
4	SEC. 7. DUTIES AND AUTHORITIES OF FEDERAL AGENCIES				
5	(a) TECHNICAL ASSISTANCE AND GRANTS.—				
6	(1) In general.—The Secretary may provide				
7	technical assistance and, subject to the availability				
8	of appropriations, grants to—				
9	(A) units of government, nonprofit organi-				
10	zations, and other persons, at the request of the				
11	Alliance; and				
12	(B) the Alliance, for use in developing and				
13	implementing the management plan.				
14	(2) Prohibition of Certain require-				
15	MENTS.—The Secretary may not, as a condition of				
16	the award of technical assistance or grants under				
17	this section, require any recipient of the technical				
18	assistance or a grant to enact or modify any land				
19	use restriction.				
20	(3) Determinations regarding assist-				
21	ANCE.—The Secretary shall determine whether a				
22	unit of government, nonprofit organization, or other				
23	person shall be awarded technical assistance or				
24	orants and the amount of technical assistance				

1	(A) based on the extent to which the as-
2	sistance—
3	(i) fulfills the objectives of the man-
4	agement plan; and
5	(ii) achieves the purposes of this Act;
6	and
7	(B) after giving special consideration to
8	projects that provide a greater leverage of Fed-
9	eral funds.
10	(b) Provision of Information.—In cooperation
11	with other Federal agencies, the Secretary shall provide
12	the public with information concerning the location and
13	character of the Heritage Area.
14	(c) Other Assistance.—The Secretary may enter
15	into cooperative agreements with public and private orga-
16	nizations for the purposes of implementing this section.
17	(d) Duties of Other Federal Agencies.—A
18	Federal entity conducting any activity directly affecting
19	the Heritage Area shall—
20	(1) consider the potential effect of the activity
21	on the management plan; and
22	(2) consult with the Alliance with respect to the
23	activity to minimize the adverse effects of the activ-
24	ity on the Heritage Area.

1	SEC. 8. NO EFFECT ON LAND USE AUTHORITY AND PRI-
2	VATE PROPERTY.
3	(a) NO EFFECT ON LAND USE AUTHORITY.—Noth-
4	ing in this Act modifies, enlarges, or diminishes any au-
5	thority of Federal, State, or local government to regulate
6	any use of land under any other law (including regula-
7	tions).
8	(b) No Zoning or Land Use Powers.—Nothing
9	in this Act grants powers of zoning or land use control
10	to the Alliance.
11	(e) Local Authority and Private Property
12	NOT AFFECTED.—Nothing in this Act affects or author-
13	izes the Alliance to interfere with—
14	(1) the right of any person with respect to pri-
15	vate property; or
16	(2) any local zoning ordinance or land use plan
17	of the State or a political subdivision of the State.
18	SEC. 9. AUTHORIZATION OF APPROPRIATIONS.
19	(a) In General.—There is authorized to be appro-
20	priated to carry out this Act \$10,000,000, of which not
21	more than \$1,000,000 may be made available for any fis-
22	cal year.
23	(b) Federal Share.—The Federal share of the cost

- 24 of any activity carried out using funds made available
- 25 under this Act shall not exceed 50 percent.

### 1 SEC. 10. TERMINATION OF AUTHORITY.

- 2 The authority of the Secretary to provide assistance
- 3 under this Act terminates on the date that is 15 years
- 4 after the date of enactment of this Act.
