### 1 SEC. 2. FINDINGS AND PURPOSES.

2 (a) FINDINGS.—Congress makes the following find-

3 ings:

4 (1) The right of all eligible citizens to vote and
5 have their vote counted is the cornerstone of a demo6 cratic form of government and the core precondition
7 of government of the people, by the people, and for
8 the people.

9 (2) The right of citizens of the United States
10 to vote is a fundamental civil right guaranteed under
11 the United States Constitution.

(3) Congress has an obligation to reaffirm the
right of each American to have an equal opportunity
to vote and have that vote counted in Federal elections, regardless of color, ethnicity, disability, language, or the resources of the community in which
they live.

1 (4) Congress has an obligation to ensure the 2 uniform and nondiscriminatory exercise of that right 3 by removing barriers in the form of election adminis-4 tration procedures and technology and insufficient and unequal resources of State and local govern-5 6 ments. 7 (b) PURPOSES.—The purposes of this Act are as fol-8 lows: 9 (1) To secure the opportunity to participate in 10 democracy for all eligible American citizens by estab-

11 lishing a national Federal write-in absentee ballot
12 for Federal elections.

13 (2) To expand and establish uniform and non14 discriminatory requirements and standards to re15 move administrative procedural barriers and techno16 logical obstacles to casting a vote and having that
17 vote counted in Federal elections.

18 (3) To expand and establish uniform and non19 discriminatory requirements and standards to pro20 vide for the accessibility, accuracy, verifiability, pri21 vacy, and security of all voting systems and tech22 nology used in Federal elections.

(4) To provide a Federal funding mechanism
for the States to implement the requirements and
standards to preserve and protect voting rights and

the integrity of Federal elections in the United
 States.

3 SEC. 3. NATIONAL FEDERAL WRITE-IN ABSENTEE BALLOT.

4 (a) IN GENERAL.—

5 (1) IN GENERAL.—Title III of the Help Amer6 ica Vote Act of 2002 (42 U.S.C. 15481 et seq.) is
7 amended by adding at the end the following new
8 subtitle:

# 9 "Subtitle C—Additional 10 Requirements

11 "SEC. 321. USE OF NATIONAL FEDERAL WRITE-IN ABSEN-

### 12 TEE BALLOT.

13 "(a) IN GENERAL.—Any person who is otherwise 14 qualified to vote in a Federal election in a State shall be 15 permitted to use the national Federal write-in absentee 16 ballot prescribed by the Election Assistance Commission 17 under section 298 to cast a vote in an election for Federal 18 office.

19 "(b) SUBMISSION AND PROCESSING.—

20 "(1) IN GENERAL.—Except as otherwise pro21 vided in this section, a national Federal write-in ab22 sentee ballot shall be submitted and processed in the
23 manner provided by law for absentee ballots in the
24 State involved.

"(2) DEADLINE.—An otherwise eligible national 1 2 Federal write-in absentee ballot shall be counted if 3 postmarked or signed before the close of the polls on 4 election day and received by the appropriate State 5 election official on or before the date which is 10 6 days after the date of the election or the date pro-7 vided for receipt of absentee ballots under State law. 8 whichever is later.

9 "(c) SPECIAL RULES.—The following rules shall
10 apply with respect to national Federal write-in absentee
11 ballots:

12 "(1) In completing the ballot, the voter may 13 designate a candidate by writing in the name of the 14 candidate or by writing in the name of a political 15 party (in which case the ballot shall be counted for 16 the candidate of that political party).

"(2) In the case of the offices of President and
Vice President, a vote for a named candidate or a
vote by writing in the name of a political party shall
be counted as a vote for the electors supporting the
candidate involved.

"(3) Any abbreviation, misspelling, or other
minor variation in the form of the name of a candidate or a political party shall be disregarded in determining the validity of the ballot.

"(d) EFFECTIVE DATE.—Each State shall be re quired to comply with the requirements of this section on
 and after January 1, 2007.".

4 (2) CONFORMING AMENDMENT.—Section 401
5 of the Help America Vote Act of 2002 (42 U.S.C.

14	"(D) The requirements of this paragraph
15	shall not apply to any voting system purchased
16	before January 1, 2009, in order to meet the
17	requirements of paragraph (3)(B).".

(b) STANDARDS.—Subtitle E of the Help America

10 the day of any Federal election and on any days during
11 which early voting is allowed for a Federal election.

12 "(b) DISTRIBUTION.—The standards described in
13 subsection (a) shall provide for a uniform and nondiscrim14 inatory geographic distribution of such systems and work15 ers.

16 "(c) DEVIATION.—The standards described in sub-17 section (a) shall permit States, upon providing adequate 18 public notice, to deviate from any allocation requirements 19 in the case of unforseen circumstances such as a natural 20 disaster, terrorist attack, or a change in voter turnout.".

### 21 SEC. 7. ELECTION DAY REGISTRATION.

(a) REQUIREMENT.—Subtitle C of title III of the
Help America Vote Act of 2002, as added and amended
by this Act, is amended by adding at the end the following
new section:

15	the date of the enactment of this Act, there is no
16	voter registration requirement for individuals in the
17	State with respect to elections for Federal office.
18	"(b) EFFECTIVE DATE.—Each State shall be re-
19	quired to comply with the requirements of subsection (a)
20	on and after January 1, 2007.".
21	(b) Election Day Registration Form.—Subtitle
22	E of title II of the Help America Vote Act of 2002, as
23	added and amended by this Act, is amended by adding
24	at the end the following new section:

### 1 "SEC. 299A. ELECTION DAY REGISTRATION FORM.

2 "The Commission shall develop an election day reg-3 istration form for elections for Federal office.".

### **4** SEC. 8. INTEGRITY OF VOTER REGISTRATION LIST.

17 "(1) IN GENERAL.—No individual shall be re18 moved from the voter registration list under section
19 303 unless such individual is first provided with a
20 notice which meets the requirements of paragraph

24 "(A) provided to each voter in a uniform25 and nondiscriminatory manner;

8 (d) NIST AUTHORITY.—Subtitle E of title II of the

"At the request of the Commission, the Director of
