A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Emergency Lease Re-
- 3 quirements Act of 2005".
- 4 SEC. 2. EMERGENCY LEASES.
- 5 Section 3307 of title 40, United States Code, is
- 6 amended by striking subsection (e) and inserting the fol-
- 7 lowing:
- 8 "(e) Emergency Leases by the Adminis-
- 9 TRATOR.—
- "(1) IN GENERAL.—Nothing in this section pre-
- vents the Administrator from entering into an emer-
- gency lease during a major disaster or other emer-
- gency declared by—
- 14 "(A) the President under section 401 of
- the Robert T. Stafford Disaster Relief and
- 16 Emergency Assistance Act (42 U.S.C. 5170); or
- 17 "(B) the head of a Federal agency under
- 18 applicable Federal law.
- 19 "(2) Lease term.—The term of an emergency
- lease under this subsection shall be not more than
- 5 years, unless the prospectus of the lease is ap-
- proved under subsection (a).
- 23 "(3) Report.—Not later than April 1 of each
- year, the Administrator shall submit to the Com-
- 25 mittee on Transportation and Infrastructure of the
- House of Representatives and the Committee on En-

- 1 vironment and Public Works of the Senate a report
- 2 describing any emergency lease entered into under
- 3 this subsection during the preceding fiscal year.".

4 SEC. 3. EFFECTIVE DATE.

- 5 This Act and the amendments made by this Act af-
- 6 fect only emergency leases entered into after August 1,
- 7 2005.
