A BILL

To expand the responsibilities of the Special Inspector General for Iraq Reconstruction to provide independent and objective audits and investigations relating to the Federal programs for Hurricane Katrina recovery.

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Special Inspector Gen-
- 3 eral for Relief and Reconstruction Act of 2005".
- 4 SEC. 2. SPECIAL INSPECTOR GENERAL FOR RELIEF AND
- 5 RECONSTRUCTION.
- 6 (a) Redesignation.—(1) Section 3001 of the Emer-
- 7 gency Supplemental Appropriations Act for Defense and
- 8 for the Reconstruction of Iraq and Afghanistan, 2004
- 9 (Public Law 108–106; 117 Stat. 1234; 5 U.S.C. App. 3

20	priated funds for Hurricane Katrina recovery activi-				
21	ties.				
22	"(iv) In the case of any contract described in				
23	paragraph (2)—				
24	"(I) the amount of the contract or other				
25	agreement;				

1	"(II) a brief discussion of the scope of the				
2	contract or other agreement;				
3	"(III) a discussion of how the contracting				
4	department or agency identified, and solicited				
5	offers from, potential contractors to perform				
6	the contract, together with a list of the poten-				
7	tial contractors that were issued solicitations				
8	for the offers; and				
9	"(IV) the justification and approval docu-				
10	ments on which was based the determination to				
11	use procedures other than procedures that pro-				
12	vide for full and open competition.				
13	"(B) The first quarterly report required to be sub-				
14	mitted under subparagraph (A) shall also summarize ac-				
15	tivities for Hurricane Katrina recovery undertaken before				
16	that quarter.				
17	"(2) A contract described in this paragraph is any				
18	major contract or other agreement that is entered into by				
19	any department or agency of the United States Govern-				
20	ment that involves the use of amounts appropriated or				
21	otherwise made available for Hurricane Katrina recovery				
22	with any public or private sector entity.				
23	"(3) Not later than 45 days after the date of enact-				
24	ment of the Special Inspector General for Relief and Re-				
25	construction Act of 2005, the Inspector General shall sub-				

- 1 mit to the appropriate committees of Congress an interim
- 2 report on the status of Hurricane Katrina recovery activi-
- 3 ties of the Federal Government. The interim report shall
- 4 include the following:
- 5 "(A) The operational activities of the Office of
- 6 the Special Inspector General for Relief and Recon-
- 7 struction.
- 8 "(B) The status of auditors and investigators
- 9 deployed to the Gulf of Mexico region of the United
- 10 States.
- 11 "(C) A strategic plan for oversight, including
- audits of no bid contracts.
- 13 "(D) Vulnerabilities identified and immediate
- actions to address such vulnerabilities.
- 15 "(E) Measures taken to coordinate interagency
- oversight elements.
- 17 "(4) Not later than March 31, 2006, and semiannu-
