A BILL

To provide for the continued education of students affected by Hurricane Katrina.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. DEFINITION OF STUDENT AFFECTED BY HUR-
- 4 RICANE KATRINA.
- 5 In this Act, the term "student affected by Hurricane
- 6 Katrina" means a student who resides or resided on Au-
- 7 gust 22, 2005 in an area, or is enrolled or was enrolled
- 8 on August 22, 2005 in a school located in an area, for
- 9 which a major disaster has been declared in accordance
- 10 with section 401 of the Robert T. Stafford Disaster Relief

- 1 and Emergency Assistance Act (42 U.S.C. 5170) as a re-
- 2 sult of Hurricane Katrina.

3 SEC. 2. EDUCATION EXPENSES.

- 4 (a) In General.—Upon the request of the Secretary
- 5 of Education, the Secretary of Homeland Security may
- 6 transfer any funds made available to the Federal Emer-
- 7 gency Management Agency "Disaster Relief Fund" for
- 8 Hurricane Katrina to the Department of Education for
- 9 the education of students affected by Hurricane Katrina.
- 10 Such funds shall only be used for expenditures for activi-
- 11 ties of educational agencies authorized under Federal law
- 12 within the jurisdiction of the Department of Education,
- 13 and for the following activities in support of students af-
- 14 fected by Hurricane Katrina:
- 15 (1) Paying the compensation of personnel, in-
- 16 cluding teacher aides, to provide instructional serv-
- ices.
- 18 (2) Paying the operational costs incurred by
- 19 educational agencies as a result of educating such
- students.
- 21 (3) Purchasing instructional materials and
- equipment, including textbooks, used to educate such
- 23 students.

- 1 (b) Special Rule.—Notwithstanding any other pro-
- 2 vision of this section, funds may be used for expenditures
- 3 described in subsection (a) only if—
- 4 (1) the Secretary of Education makes a deter-
- 5 mination that such expenditures constitute an imme-
- 6 diate need for the relief of students affected by Hur-
- 7 ricane Katrina; and
- 8 (2) funds are not made available for such ac-
- 9 tivities from other Federal sources.

10 SEC. 3. AVAILABILITY OF FUNDS.

- 11 (a) IN GENERAL.—Notwithstanding any other provi-
- 12 sion of law, any funds available to the Secretary of Edu-
- 13 cation, the authority for which would be cancelled or oth-
- 14 erwise expire on September 30, 2005, shall be available
- 15 for obligation by the Secretary until September 30, 2006,
- 16 but only to meet educational needs of students affected
- 17 by Hurricane Katrina.
- 18 (b) Emergency Designation.—Any funds available
- 19 for obligation pursuant to subsection (a) are designated
- 20 as an emergency requirement pursuant to section 402 of
- 21 H. Con. Res. 95 (109th Congress).

22 SEC. 4. ADVANCED NOTIFICATION OF CONGRESS.

- 23 (a) Department of Education Appropriations
- 24 Act, 2005.—Section 304 of the Department of Education

- 1 Appropriations Act, 2005 (Public Law 108–447) is
- 2 amended by striking "15 days" and inserting "3 days".
- 3 (b) Consolidated Appropriations Act, 2005.—
- 4 Section 517 of the Departments of Labor, Health and
- 5 Human Services, and Education, and Related Agencies
- 6 Appropriations Act, 2005 (Public Law 108–447) is
- 7 amended—
- 8 (1) in subsection (a), by striking "15 days" and
- 9 inserting "3 days"; and
- 10 (2) in subsection (b), by striking "15 days" and
- inserting "3 days".
- 12 **SEC. 5. SUNSET.**
- 13 This Act shall be effective for the period beginning
- 14 on the date of enactment of this Act and ending on Sep-
- 15 tember 30, 2006.
