AN ACT

To provide for the continued education of students affected by Hurricane Katrina.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. DEFINITION OF STUDENT AFFECTED BY HUR-

- 3 In this Act, the term "student affected by Hurricane
- 4 Katrina" means a student who resides or resided on Au-
- 5 gust 22, 2005 in an area, or is enrolled or was enrolled
- 6 on August 22, 2005 in a school located in an area, for
- 7 which a major disaster has been declared in accordance
- 8 with section 401 of the Robert T. Stafford Disaster Relief
- 9 and Emergency Assistance Act (42 U.S.C. 5170) as a re-
- 10 sult of Hurricane Katrina.

11 SEC. 2. EDUCATION EXPENSES.

- 12 (a) IN GENERAL.—Upon the request of the Secretary
- 13 of Education, the Secretary of Homeland Security may
- 14 transfer any funds made available to the Federal Emer-
- 15 gency Management Agency "Disaster Relief Fund" for
- 16 Hurricane Katrina to the Department of Education for
- 17 the education of students affected by Hurricane Katrina.
- 18 Such funds shall only be used for expenditures for activi-
- 19 ties of educational agencies authorized under Federal law
- 20 within the jurisdiction of the Department of Education,
- 21 and for the following activities in support of students af-
- 22 fected by Hurricane Katrina:
- 23 (1) Paying the compensation of personnel, in-
- 24 cluding teacher aides, to provide instructional serv-
- ices.

- 1 (2) Paying the operational costs incurred by 2 educational agencies as a result of educating such 3 students.
- 4 (3) Purchasing instructional materials and 5 equipment, including textbooks, used to educate such 6 students.
- 7 (b) Special Rule.—Notwithstanding any other pro-8 vision of this section, funds may be used for expenditures 9 described in subsection (a) only if—
- 10 (1) the Secretary of Education makes a deter11 mination that such expenditures constitute an imme12 diate need for the relief of students affected by Hur13 ricane Katrina; and
- 14 (2) funds are not made available for such ac-15 tivities from other Federal sources.

16 SEC. 3. AVAILABILITY OF FUNDS.

- 17 (a) In General.—Notwithstanding any other provi-
- 18 sion of law, any funds available to the Secretary of Edu-
- 19 cation, the authority for which would be cancelled or oth-
- 20 erwise expire on September 30, 2005, shall be available
- 21 for obligation by the Secretary until September 30, 2006,
- 22 but only to meet educational needs of students affected
- 23 by Hurricane Katrina.
- 24 (b) Emergency Designation.—Any funds available
- 25 for obligation pursuant to subsection (a) are designated

- 1 as an emergency requirement pursuant to section 402 of
- 2 H. Con. Res. 95 (109th Congress).

- 17 **SEC. 5. SUNSET.**
- 18 This Act shall be effective for the period beginning
- 19 on the date of enactment of this Act and ending on Sep-
- 20 tember 30, 2006.
