Mr. CORNYN introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

To protect consumers, creditors, workers, pensioners, shareholders, and small businesses, by reforming the rules governing venue in bankruptcy cases to combat forum shopping by corporate debtors.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fairness in Bank-

5 ruptcy Litigation Act of 2005”.

6 **SEC. 2. VENUE IN BANKRUPTCY CASES.**

7 Section 1408 of title 28, United States Code, is

8 amended—

1 (1) by inserting “(a)” before “Except”;

2 (2) in paragraph (1), by striking “or” at the
3 end; and

4 (3) by striking paragraph (2) and inserting the
5 following:

6 “(2) in which a case under title 11 concerning
7 the controlling corporation is pending, if—

8 “(A) the debtor is controlled by another
9 corporation;

10 “(B) within the 730 days before the date
11 of the debtor’s filing under title 11, the finan-
12 cial statements of the debtor have been consoli-
13 dated with those of the controlling corporation
14 in 1 or more reports filed under section 13 or
15 15(d) of the Securities Exchange Act of 1934;
16 and

17 “(C) the controlling corporation is a debtor
18 in a proceeding under title 11; or

19 “(3) in which a case under title 11 concerning
20 the controlling corporation is pending, if—

21 “(A) the debtor is a corporation other than
22 a corporation described in paragraph (2);

23 “(B) the debtor has been controlled by an-
24 other corporation for not less than 365 days be-

1 fore the date of the filing of the debtor’s peti-
2 tion under title 11; and

3 “(C) the controlling corporation is a debtor
4 in a proceeding under title 11.

5 “(b) For purposes of subsection (a)—

6 “(1) if the debtor is a corporation, the domicile
7 and residence of the debtor are located where the
8 debtor’s principal place of business is located; and

9 “(2) the term ‘control’ has the meaning given
10 that term in section 2 of the Bank Holding Com-
11 pany Act of 1956 (12 U.S.C. 1841).”.

12 **SEC. 3. CURE OR WAIVER OF DEFECTS.**

13 Section 1406(c) of title 28, United States Code, is
14 amended to read as follows:

15 “(c) As used in this section—

16 “(1) the term ‘district court’—

17 “(A) includes the District Court of Guam,
18 the District Court of the Northern Mariana Is-
19 lands, and the District Court of the Virgin Is-
20 lands; and

21 “(B) with regard to cases pending before a
22 bankruptcy court, includes a bankruptcy court;
23 and

1 “(2) the term ‘district’ includes the territorial
2 jurisdiction of each district court.”.
