Mr. Harkin (for himself, Mr. Grassley, Mr. DeWine, Mr. Brownback, Mr. Talent, Ms. Snowe, and Mr. Lautenberg) introduced the following bill; which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To reduce the incidence of suicide among veterans.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Joshua Omvig Vet-
- 5 erans Suicide Prevention Act".
- 6 SEC. 2. COMPREHENSIVE PROGRAM FOR SUICIDE PREVEN-
- 7 TION AMONG VETERANS.
- 8 (a) Program Required.—The Secretary of Vet-
- 9 erans Affairs shall develop and implement a comprehen-
- 10 sive program for reducing the incidence of suicide among
- 11 veterans.

(b) Program Elements.—

- (1) DE-STIGMATIZING MENTAL HEALTH.—The program required by subsection (a) shall include a national mental health campaign to increase awareness in the veteran community that mental health is essential to overall health and that very effective modern treatments can promote recovery from mental illness. The campaign may include the following:
 - (A) Activities targeted at veterans of Operation Iraqi Freedom and Operation Enduring Freedom and the families of such veterans.
 - (B) Monthly messages on the Internet website of the Department of Veterans Affairs that express the theme that mental health is essential to overall health.
 - (C) Inclusion of the theme described in subparagraph (B) in public addresses, speeches, and veterans service organization convention addresses by the Secretary of Veterans Affairs and other senior officials of the Department.
- (2) Training of employees and other personnel.—The program shall provide for mandatory training on suicide and suicide prevention for appropriate employees and contractor personnel (including all medical personnel) of the Department of Vet-

1	erans Affairs who interact with veterans. Such train-
2	ing shall include information pertinent to the job of
3	such employees and personnel, including information
4	on the following:
5	(A) Recognition of risk factors for suicide.
6	(B) Protocols for responding to crisis situ-
7	ations involving veterans who may be at high
8	risk for suicide.
9	(C) Best practices for suicide prevention.
10	(3) Family education.—The program shall
11	include programs targeted at family members of vet-
12	erans to assist such family members—
13	(A) understanding issues that arise in the
14	readjustment of veterans to civilian life;
15	(B) identifying signs and symptoms of
16	mental health problems; and
17	(C) encouraging veterans to seek assist-
18	ance for such problems.
19	(4) Peer support program.—
20	(A) IN GENERAL.—The program shall pro-
21	vide support for the development of a program
22	to enable veterans to serve as peer counselors to
23	assist other veterans with mental health issues.
24	(B) PEER SUPPORT COUNSELING AS A
25	SUPPLEMENTAL SERVICE.—The program sup-

- ported by subparagraph (A) shall be offered in addition to other mental health services already offered by the Department and services created pursuant to this Act.
 - (5) HEALTH ASSESSMENTS OF VETERANS.—
 The program shall encourage all veterans, when they apply for benefits provided by the Department, to undergo a mental health assessment at a Department of Veterans Affairs medical facility (including a center established under section 1712A of title 38, United States Code).
 - (6) Counseling and treatment of vet-ERANS.—The program shall provide for referrals to appropriate counseling and treatment programs for veterans who show signs or symptoms of mental health problems.
 - (7) Suicide prevention counselors.—The program shall provide for the designation of a suicide prevention counselor at each Department of Veterans Affairs medical facility other than centers established under section 1712A of title 38, United States Code. Each counselor shall work with local emergency rooms, law enforcement agencies, local mental health organizations, and veterans service organizations to engage in outreach to veterans to in-

1	form them of mental health services that are avail-
2	able to them and to improve the coordination of
3	mental health care to veterans at the local level.
4	(8) Access to mental health services.—
5	The program shall include mechanisms to ensure
6	that veterans in rural and geographically remote
7	areas have access to quality mental health care. In
8	ensuring the delivery of quality mental health care
9	to such veterans, the Secretary of Veterans Affairs
10	shall collaborate with the following agencies:
11	(A) The Department of Health and
12	Human Services.
13	(B) The National Institute of Mental
14	Health.
15	(C) The Indian Health Service.
16	(D) The Health Resources and Services
17	Administration.
18	(E) The Substance Abuse and Mental
19	Health Services Administration.
20	(9) Research on best practices.—
21	(A) IN GENERAL.—The program shall pro-
22	vide for research on best practices for suicide
23	prevention among veterans.
24	(B) Steering committee.—The Sec-
25	retary of Veterans Affairs shall develop a steer-

1	ing committee to advise the Secretary of Vet-
2	erans Affairs on the research described in sub-
3	paragraph (A). Such steering committee shall
4	be comprised of representatives from the fol-
5	lowing:
6	(i) National Institute of Mental
7	Health.
8	(ii) Substance Abuse and Mental
9	Health Services Administration.
10	(iii) Centers for Disease Control and
11	Prevention.
12	(10) RESEARCH ON SEXUAL TRAUMA.—The
13	program shall provide for research on mental health
14	care for veterans who experience sexual trauma
15	while in service in the Armed Forces, including
16	members who experience such trauma while serving
17	in a reserve component of the Armed Forces.
18	(11) 24-HOUR MENTAL HEALTH CARE.—The
19	program shall include mechanisms to ensure the
20	availability of services for mental health care for vet-
21	erans on a 24-hour basis.
22	(12) Telephone Hotline.—The program
23	may include a toll-free telephone number (commonly
24	referred to as an "800 number") through which vet-

erans may obtain information on and referrals to ap-

- propriate mental health services. The telephone number shall be serviced by personnel with appropriate mental health training, and shall be operational at all times.
- 5 (13) OTHER ELEMENTS.—The program may 6 provide for such other activities and programs to re-7 duce the incidence of suicide among veterans as the 8 Secretary of Veterans Affairs considers appropriate.

9 SEC. 3. REPORT TO CONGRESS ON SUICIDE PREVENTION

10 PROGRAMS AND ACTIVITIES.

- 11 (a) Report Required.—Not later than 90 days
- 12 after the date of the enactment of this Act, the Secretary
- 13 of Veterans Affairs shall submit to Congress a report on
- 14 the programs and activities of the Department of Veterans
- 15 Affairs to reduce the incidence of suicide among veterans.
- 16 (b) Elements.—The report shall include the fol-17 lowing:
- 18 (1) A description of the status of the implemen-19 tation of the program required by section 2(a).
- 20 (2) A description of the scheduled implementa-21 tion of the program during the two-year period be-22 ginning on the date of the enactment of this Act, in-23 cluding the costs of implementation of the program 24 over that period.

1	(3) A plan for additional programs and activi-
2	ties to reduce the incidence of suicide among vet-
3	erans.
4	(4) Such recommendations for additional legis-
5	lative or administrative action as the Secretary con-
6	siders appropriate to improve and enhance the sui-
7	cide prevention programs and activities of the De-
8	partment.
9	(c) Consultation.—In developing the plan required
10	by subsection (b)(3), the Secretary shall consult with the
11	following:
12	(1) The National Institute of Mental Health.
13	(2) The Substance Abuse and Mental Health
14	Services Administration.
15	(3) Centers for Disease Control and Prevention.
16	SEC. 4. SENSE OF CONGRESS.
17	It is the sense of Congress that—
18	(1) suicide among veterans suffering from post-
19	traumatic stress disorder (PTSD) is a serious prob-
20	lem; and
21	(2) the Secretary of Veterans Affairs should
22	take into consideration the special needs of veterans
23	suffering from post-traumatic stress disorder in de-

- 1 veloping and implementing the comprehensive pro-
- 2 gram required by section 2(a).
