Mr. LEVIN introduced the following bill; which was read twice and referred to the Committee on the Judiciary

A BILL

For the relief of Perlat Binaj, Almida Binaj, Erina Binaj,
and Anxhela Binaj.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR PERLAT**
4 **BINAJ, ALMIDA BINAJ, ERINA BINAJ, AND**
5 **ANXHELA BINAJ.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)
7 and (b) of section 201 of the Immigration and Nationality
8 Act (8 U.S.C. 1151), Perlat Binaj, Almida Binaj, Erina
9 Binaj, and Anxhela Binaj shall be eligible for issuance of
10 immigrant visas or for adjustment of status to that of

1 aliens lawfully admitted for permanent residence upon fil-
2 ing applications for issuance of immigrant visas under sec-
3 tion 204 of such Act or for adjustment of status to lawful
4 permanent resident.

5 (b) ADJUSTMENT OF STATUS.—If Perlat Binaj,
6 Almida Binaj, Erina Binaj, and Anxhela Binaj enter the
7 United States before the filing deadline specified in sub-
8 section (c), Perlat Binaj, Almida Binaj, Erina Binaj, and
9 Anxhela Binaj shall be considered to have entered and re-
10 mained lawfully in the United States and shall be eligible
11 for adjustment of status under section 245 of the Immi-
12 gration and Nationality Act (8 U.S.C. 1255) as of the date
13 of the enactment of this Act.

14 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
15 FEES.—Subsections (a) and (b) shall apply only if the ap-
16 plications for issuance of immigrant visas or the applica-
17 tions for adjustment of status are filed with appropriate
18 fees not later than 2 years after the date of the enactment
19 of this Act.

20 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—
21 Upon the granting of immigrant visas or adjustment of
22 status to that of aliens lawfully admitted for permanent
23 residence to Perlat Binaj, Almida Binaj, Erina Binaj, and
24 Anxhela Binaj, the Secretary of State shall instruct the
25 proper officer to reduce by 4, during the current or next

1 following fiscal year, the total number of immigrant visas
2 that are made available to natives of the country of the
3 aliens' birth under section 203(a) of the Immigration and
4 Nationality Act (8 U.S.C. 1153(a)) or, if applicable, the
5 total number of immigrant visas that are made available
6 to natives of the country of the aliens' birth under section
7 202(e) of such Act.
