Mr. LUGAR introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To authorize the extension of unconditional and permanent nondiscriminatory treatment (permanent normal trade relations treatment) to the products of Ukraine, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that Ukraine—

5 (1) allows its citizens the right and opportunity
6 to emigrate, free of any heavy tax on emigration or
7 on the visas or other documents required for emigra-
8 tion and free of any tax, levy, fine, fee, or other

1 charge on any citizens as a consequence of the desire
2 of such citizens to emigrate to the country of their
3 choice;

4 (2) has received normal trade relations treat-
5 ment since concluding a bilateral trade agreement
6 with the United States that entered into force on
7 June 23, 1992, which remains in force and provides
8 the United States with important rights;

9 (3) has been found to be in full compliance with
10 the freedom of emigration requirements under title
11 IV of the Trade Act of 1974 since 1997;

12 (4) has committed itself to ensuring freedom of
13 religion and preventing intolerance;

14 (5) has committed itself to continuing its ef-
15 forts to return religious property to religious organi-
16 zations in accordance with existing law;

17 (6) has taken significant steps demonstrating
18 its intentions to build a friendly and cooperative re-
19 lationship with the United States including partici-
20 pating in peacekeeping efforts in Europe; and

21 (7) has made progress toward meeting inter-
22 national commitments and standards in the most re-
23 cent Presidential runoff elections, including in the
24 implementation of Ukraine's new elections laws.

1 **SEC. 2. TERMINATION OF APPLICATION OF TITLE IV OF**
2 **THE TRADE ACT OF 1974 TO UKRAINE.**

3 (a) **PRESIDENTIAL DETERMINATIONS AND EXTEN-**
4 **SION OF UNCONDITIONAL AND PERMANENT NONDISCRIM-**
5 **INATORY TREATMENT.**—Notwithstanding any provision of
6 title IV of the Trade Act of 1974 (19 U.S.C. 2431 et seq.),
7 the President may—

8 (1) determine that such title should no longer
9 apply to Ukraine; and

10 (2) after making a determination under para-
11 graph (1) with respect to Ukraine, proclaim the ex-
12 tension of unconditional and permanent nondiscrim-
13 inatory treatment (permanent normal trade relations
14 treatment) to the products of that country.

15 (b) **TERMINATION OF APPLICATION OF TITLE IV.**—
16 On and after the effective date of the extension under sub-
17 section (a)(2) of nondiscriminatory treatment to the prod-
18 ucts of Ukraine, chapter 1 of title IV of the Trade Act
19 of 1974 shall cease to apply to that country.
