- 3 SECTION 1. USE OF ROTUNDA FOR GOLD MEDAL CERE-
- 4 MONY FOR DALAI LAMA.
- 5 (a) USE OF ROTUNDA.—The rotunda of the Capitol
- 6 is authorized to be used on October 17, 2007, for a cere-
- 7 mony to award the Congressional Gold Medal to Tenzin

2	Public Law 109–287.
3	(b) Preparations.—Physical preparations for the
4	ceremony referred to in subsection (a) shall be carried out
5	in accordance with such conditions as the Architect of the
6	Capitol may prescribe.
7	SEC. 2. USE OF CAPITOL GROUNDS IN CONNECTION WITH
8	CEREMONY.
9	(a) In General.—The International Campaign for
10	Tibet (in this resolution referred to as the "sponsor") shall
11	be permitted to sponsor a public event on the Capitol
12	Grounds (in this resolution referred to as the "event") on
13	October 17, 2007, in connection with the ceremony to be
14	held in the rotunda of the Capitol under section 1.
15	(b) TERMS AND CONDITIONS.—
16	(1) In general.—Under conditions to be pre-
17	scribed by the Architect of the Capitol and the Cap-
18	itol Police Board, the event shall be—
19	(A) free of admission charge and open to
20	the public; and
21	(B) arranged not to interfere with the
22	needs of Congress.
23	(2) Expenses and liabilities.—The sponsor
24	shall assume full responsibility for all expenses and

- 1 liabilities incident to all activities associated with the
- 2 event.
- 3 (c) Event Preparations.—Subject to the approval
- 4 of the Architect of the Capitol, the sponsor is authorized
- 5 to erect upon the Capitol Grounds such stage, sound am-
- 6 plification devices, and other related structures and equip-
- 7 ment, as may be required for the event.
- 8 (d) Enforcement of Restrictions.—The Capitol
- 9 Police Board shall provide for enforcement of the restric-
- 10 tions contained in section 5104(c) of title 40, United
- 11 States Code, concerning sales, advertisements, displays,
- 12 and solicitations on the Capitol Grounds, as well as other
- 13 restrictions applicable to the Capitol Grounds, in connec-
- 14 tion with the event.
