# A BILL

  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,

#### **3** SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Student Aid Reward

5 Act of 2007".

#### 6 SEC. 2. STUDENT AID REWARD PROGRAM.

Part G of title IV of the Higher Education Act of
1965 (20 U.S.C. 1088 et seq.) is amended by inserting
after section 489 the following:

#### 1 "SEC. 489A. STUDENT AID REWARD PROGRAM.

2 "(a) PROGRAM AUTHORIZED.—The Secretary shall
3 carry out a Student Aid Reward Program to encourage
4 institutions of higher education to participate in the stu5 dent loan program under this title that is most cost-effec6 tive for taxpayers.

7 "(b) PROGRAM REQUIREMENTS.—In carrying out the8 Student Aid Reward Program, the Secretary shall—

9 "(1) provide to each institution of higher edu-10 cation participating in the student loan program 11 under this title that is most cost-effective for tax-12 payers, a Student Aid Reward Payment, in an 13 amount determined in accordance with subsection 14 (c), to encourage the institution to participate in 15 that student loan program;

"(2) require each institution of higher education receiving a payment under this section to provide student loans under such student loan program
for a period of 5 years after the date the first payment is made under this section;

"(3) where appropriate, require that funds paid
to institutions of higher education under this section
be used to award students a supplement to such students' Federal Pell Grants under subpart 1 of part
A;

"(4) permit such funds to also be used to award
 need-based grants to lower- and middle-income grad uate students; and

4 "(5) encourage all institutions of higher edu5 cation to participate in the Student Aid Reward Pro6 gram under this section.

7 "(c) AMOUNT.—The amount of a Student Aid Re-8 ward Payment under this section shall be not less than 9 50 percent of the savings to the Federal Government gen-10 erated by the institution of higher education's participation in the student loan program under this title that is 11 12 most cost-effective for taxpayers instead of the institu-13 tion's participation in the student loan program that is not most cost-effective for taxpavers. 14

- 15 "(d) TRIGGER TO ENSURE COST NEUTRALITY.—
- 16 "(1) LIMIT TO ENSURE COST NEUTRALITY.—
  17 Notwithstanding subsection (c), the Secretary shall
  18 not distribute Student Aid Reward Payments under
  19 the Student Aid Reward Program that, in the aggre20 gate, exceed the Federal savings resulting from the
  21 implementation of the Student Aid Reward Pro22 gram.

23 "(2) FEDERAL SAVINGS.—In calculating Fed24 eral savings, as used in paragraph (1), the Secretary
25 shall determine Federal savings on loans made to

1	students at institutions of higher education that par-
2	ticipate in the student loan program under this title
3	that is most cost-effective for taxpayers and that, on
4	the date of enactment of this section, participated in
5	the student loan program that is not most cost-effec-
6	tive for taxpayers, resulting from the difference of—
7	"(A) the Federal cost of loan volume made
8	under the student loan program under this title
9	that is most cost-effective for taxpayers; and
10	"(B) the Federal cost of an equivalent type
11	and amount of loan volume made, insured, or
12	guaranteed under the student loan program
13	under this title that is not most cost-effective
14	for taxpayers.
15	"(3) DISTRIBUTION RULES.—If the Federal
16	savings determined under paragraph (2) is not suffi-
17	cient to distribute full Student Aid Reward Pay-
18	ments under the Student Aid Reward Program, the
19	Secretary shall—
20	"(A) first make Student Aid Reward Pay-
21	ments to those institutions of higher education
22	that participated in the student loan program
23	under this title that is not most cost-effective
24	for taxpayers on the date of enactment of this
25	section; and

1	"(B) with any remaining Federal savings
2	after making Student Aid Reward Payments
3	under subparagraph (A), make Student Aid Re-
4	ward Payments to the institutions of higher
5	education eligible for a Student Aid Reward
6	Payment and not described in subparagraph
7	(A) on a pro-rata basis.
8	"(4) DISTRIBUTION TO STUDENTS.—Any insti-
9	tution of higher education that receives a Student
10	Aid Reward Payment under this section—
11	"(A) shall distribute, where appropriate,
12	part or all of such payment among the students
13	of such institution who are Federal Pell Grant
14	recipients by awarding such students a supple-
15	mental grant; and
16	"(B) may distribute part of such payment
17	as a supplemental grant to graduate students in
18	financial need.
19	"(5) Estimates, adjustments, and carry
20	OVER.—
21	"(A) ESTIMATES AND ADJUSTMENTS.—
22	The Secretary shall make Student Aid Reward
23	Payments to institutions of higher education on
24	the basis of estimates, using the best data avail-
25	able at the beginning of an academic or fiscal

1	year. If the Secretary determines thereafter
2	that loan program costs for that academic or
3	fiscal year were different than such estimate,
4	the Secretary shall adjust by reducing or in-
5	creasing subsequent Student Aid Reward Pay-
6	ments paid to such institutions of higher edu-
7	cation to reflect such difference.
8	"(B) CARRY OVER.—Any institution of

9 higher education that receives a reduced Stu-10 dent Aid Reward Payment under paragraph 11 (3)(B), shall remain eligible for the unpaid por-12 tion of such institution's financial reward payment, as well as any additional financial reward 13 14 payments for which the institution is otherwise 15 eligible, in subsequent academic or fiscal years. "(e) DEFINITION.—In this section: 16

"(1) The term 'student loan program under this
title that is most cost-effective for taxpayers' means
the loan program under part B or D of this title
that has the lowest overall cost to the Federal Government (including administrative costs) for the
loans authorized by such parts.

23 "(2) The term 'student loan program under this
24 title that is not most cost-effective for taxpayers'
25 means the loan program under part B or D of this

title that does not have the lowest overall cost to the
 Federal Government (including administrative costs)

3 for the loans authorized by such parts.".
