**AN ACT**

To require the Secretary of the Interior, acting through the Bureau of Reclamation and the United States Geological Survey, to conduct a study on groundwater resources in the State of Alaska, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Alaska Water Re-  
5 sources Act of 2007”.

6 **SEC. 2. DEFINITIONS.**

7        In this Act:

8            (1) SECRETARY.—The term “Secretary” means  
9        the Secretary of the Interior.

1           (2) STATE.—The term “State” means the State  
2           of Alaska.

3 **SEC. 3. ALASKA WATER RESOURCES STUDY.**

4           (a) STUDY.—The Secretary, acting through the Com-  
5           missioner of Reclamation and the Director of the United  
6           States Geological Survey, where appropriate, and in ac-  
7           cordance with this Act and other applicable provisions of  
8           law, shall conduct a study that includes—

9                   (1) a survey of accessible water supplies, includ-  
10                  ing aquifers, on the Kenai Peninsula and in the Mu-  
11                  nicipality of Anchorage, the Matanuska-Susitna Bor-  
12                  ough, the city of Fairbanks, and the Fairbanks  
13                  Northstar Borough;

14                   (2) a survey of water treatment needs and tech-  
15                  nologies, including desalination, applicable to the  
16                  water resources of the State; and

17                   (3) a review of the need for enhancement of the  
18                  streamflow information collected by the United  
19                  States Geological Survey in the State relating to  
20                  critical water needs in areas such as—

21                           (A) infrastructure risks to State transpor-  
22                           tation;

23                           (B) flood forecasting;

24                           (C) resource extraction; and

25                           (D) fire management.

1 (b) REPORT.—Not later than 2 years after the date  
2 of the enactment of this Act, the Secretary shall submit  
3 to the Committee on Natural Resources of the House of  
4 Representatives and the Committee on Energy and Nat-  
5 ural Resources of the Senate a report describing the re-  
6 sults of the study required by subsection (a).

7 **SEC. 4. SUNSET.**

8 The authority of the Secretary to carry out any provi-  
9 sions of this Act shall terminate 10 years after the date  
10 of the enactment of this Act.

11 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

12 There are authorized to be appropriated such sums  
13 as are necessary to carry out this Act.
