8 (b) TREATMENT OF EARLIER DEATHS AND DEATH 9 GRATUITY PAYMENTS.—With respect to the death of a person covered by section 1475 or 1476 of title 10, United 10 States Code, that occurred before the date of the enact-11 ment of this Act, if the person had no surviving spouse, 12 13 but had one or more surviving children, and left a clear expression of intent regarding payment of the death gra-14 15 tuity to another person on behalf of the surviving child or children in the manner authorized by subsection (d) of 16 17 section 1477 of such title, as added by subsection (a)(3), it is the sense of Congress that the death gratuity should 18 be distributed consistent with that expression of intent. 19
