AN ACT

To provide for the construction, operation, and maintenance of an arterial road in St. Louis County, Missouri.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. PROJECT DEFINED.

- In this Act, the term "project" means only the por-
- 3 tion of St. Louis County, Missouri, arterial road 1151 that
- 4 is deed-restricted property, which specifically applies to
- 5 approximately 0.3 acres and 540 lineal feet and is identi-
- 6 fied as the "FEMA" route in the document entitled
- 7 "Lemay Connector Road for Long-Term Recovery, Rec-
- 8 reational Enhancements, & Community, & Economic De-
- 9 velopment", dated June 1, 2006, on file with the St. Louis
- 10 County department of highways and traffic.

11 SEC. 2. APPLICABILITY OF CERTAIN FEDERAL LAW.

- 12 The St. Louis County arterial road 1151, known as
- 13 the "Lemay Connector Road" in St. Louis City and Coun-
- 14 ty, Missouri, may be constructed, operated, and main-
- 15 tained over the deed-restricted property described in sec-
- 16 tion 1, notwithstanding section 404(b)(2) of the Robert
- 17 T. Stafford Disaster Relief and Emergency Assistance Act
- 18 (42 U.S.C. 5170c) or Public Law 103–211 and any ease-
- 19 ment or other similar restriction pursuant to those Fed-
- 20 eral laws on the development of property that requires the
- 21 property be maintained for open space, recreation, or wet-
- 22 land management.

23 SEC. 3. NO DETRIMENTAL EFFECT ON FLOOD PLAIN.

- For the project, St. Louis County, Missouri, shall en-
- 25 sure that the project is constructed, operated, and main-
- 26 tained in such a manner that would not cause any future

- 1 additional flood damage that would not have occurred
- 2 without the project. Prior to constructing the project, St.
- 3 Louis County or its assignee must identify and agree to
- 4 restrict a nearby parcel of land of equal or greater size
- 5 to the deed restricted land used for the project so that
- 6 such parcel is maintained for open space, recreation, or
- 7 wetland management.

8 SEC. 4. LIABILITY FOR FLOOD DAMAGE.

- 9 The Federal Government shall not be liable for future
- 10 flood damage that is caused by the project. St. Louis
- 11 County, Missouri, or its assignee shall be liable for any
- 12 future flood damage that is caused by the project.
- 13 SEC. 5. NO FUTURE DISASTER ASSISTANCE.
- 14 The deed-restricted property described in section 1
- 15 is not eligible for any future disaster assistance from any
- 16 other Federal source.
