# H.R. 1143

## AN ACT

To authorize the Secretary of the Interior to lease certain lands in Virgin Islands National Park, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

### SECTION 1. DEFINITIONS.

- 2 In this Act, the following definitions apply:
- 3 (1) Secretary.—The term "Secretary" means
- 4 the Secretary of the Interior.
- 5 (2) RUE.—The term "RUE" means the re-
- 6 tained use estate entered into by the Jackson Hole
- 7 Preserve and the United States on September 30,
- 8 1983.
- 9 (3) Park.—The term "park" means Virgin Is-
- 10 lands National Park.
- 11 (4) CBI.—The term "CBI" means CBI Acqui-
- sitions, LLC.
- 13 (5) RESORT.—The term "Resort" means
- 14 Caneel Bay Resort on the island of St. John in Vir-
- gin Islands National Park.
- 16 SEC. 2. LEASE AGREEMENT.
- 17 (a) AUTHORIZATION.—The Secretary may enter into
- 18 a lease agreement with CBI governing the use of property
- 19 for the continued management and operation of the Re-
- 20 sort.
- 21 (b) Additional Lands.—Any lease entered into
- 22 pursuant to this Act shall include the property covered by
- 23 the RUE and any associated property owned by CBI do-
- 24 nated to the National Park Service.
- 25 (c) Terms.—The lease agreement authorized under
- 26 subsection (a) shall—

- 1 (1) require that operations and maintenance of 2 the Resort are conducted in a manner consistent 3 with the preservation and conservation of the re-4 sources and values of the Park as well as the best 5 interests of the Resort;
  - (2) be for the minimum number of years practicable to enable the lessee to secure financing for any necessary improvements to the Resort, taking into account the financial obligations of CBI, but in any event shall not exceed 40 years;
  - (3) prohibit any transfer, assignment or sale of the lease or otherwise convey or pledge any interest in the lease without prior written notification to and approval by the Secretary;
  - (4) prohibit any increase in the number of guest accommodations available at the Resort;
  - (5) prohibit any increase in the overall size of the Resort;
  - (6) prohibit the sale of partial ownership shares or timeshares in the Resort;
  - (7) be designed to facilitate transfer of all property covered by the lease to Federal administration upon expiration of the lease; and

1	(8) include any other provisions determined by					
2	the Secretary to be necessary to protect the Park					
3	and the public interest.					
4	(d) Appraisals.—The Secretary shall require ap-					
5	praisals to determine the fair market value of all property					
6	covered by the RUE and any property, including the value					
7	if any, of the surrendered term of the RUE, owned by					
8	CBI to be donated, or otherwise conveyed, to the National					
9	Park Service. Such appraisals shall be conducted pursuant					
10	to the Uniform Appraisal Standards for Federal Land Ac-					
11	quisition.					
12	(e) Compensation.—					
13	(1) In general.—The lease authorized by this					
14	Act shall—					
15	(A) require payment to the United States					
16	of the property's fair market value rent, taking					
17	into account the value of any associated prop-					
18	erty transferred by CBI as well as the value, if					
19	any, of the surrendered term of the RUE;					
20	(B) include a provision—					
21	(i) allowing recalculation of the					
22	amount of the payment required under this					
23	subsection, at the request of the Secretary					
24	or CBI, in the event of extraordinary un-					
25	anticipated changes in conditions antici-					

1	pated at the time the lease was finalized;						
2	and						
3	(ii) providing for binding arbitration						
4	in the event the Secretary and CBI are un-						
5	able to agree upon an adjustment to the						
6	payment in these circumstances.						
7	(2) DISTRIBUTION.—Eighty percent of the pay-						
8	ment to the United States required by this sub						
9	section shall be available to the Secretary, withou						
10	further appropriation, for expenditure within the						
11	Park. The remaining twenty percent shall be depos-						
12	ited in the Treasury.						
13	(3) Applicability of Certain Law.—Section						
14	321 of the Act of June 30, 1932 (40 U.S.C. 1302),						
15	relating to the leasing of buildings and property of						
16	the United States, shall not apply to the lease en-						
17	tered into by the Secretary pursuant to this Act.						
18	SEC. 3. RETAINED USE ESTATE.						
19	As a condition of the lease, CBI shall relinquish to						
20	the Secretary all rights under the RUE and transfer, with-						

- 1 out compensation, ownership of improvements covered by
- 2 the RUE to the United States.
