A BILL

To amend title 38, United States Code, to provide entitlement to educational assistance under the Montgomery GI Bill for members of the Selected Reserve who aggre-

gate more than two years of active duty service in any five year period, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Resuming Education
5	After Defense Service Act of 2007".
6	SEC. 2. EDUCATIONAL ASSISTANCE UNDER MONTGOMERY
7	GI BILL FOR MEMBERS OF THE SELECTED
8	RESERVE WHO AGGREGATE MORE THAN 2
9	YEARS OF ACTIVE DUTY SERVICE DURING
10	ANY 5-YEAR PERIOD.
11	(a) Entitlement.—Section 3012(a)(1) of title 38,
12	United States Code, is amended—
13	(1) in subparagraph (B), by striking "or" at
14	the end;
15	(2) in subparagraph (C), by adding "or" at the
16	end; and
17	(3) by inserting after subparagraph (C) the fol-
18	lowing new subparagraph (D):
19	"(D) while in the Selected Reserve—
20	"(i) is first ordered to serve on active
21	duty in the Armed Forces under section
22	12301(a), 12301(d), 12301(g), 12302, or
23	12304 of title 10 during the period begin-

1	ning on September 11, 2001, and ending
2	December 31, 2008; and
3	"(ii) serves on active duty in the
4	Armed Forces for one or more periods
5	(whether continuous or otherwise) aggre-
6	gating not less than two years of service on
7	active duty during a five-year period begin-
8	ning on the date the individual is first or-
9	dered to serve on active duty during the
10	period referred to in clause (i);".
11	(b) Duration of Assistance.—Section 3013(b) of
12	such title is amended by striking "is entitled to" and all
13	that follows and inserting the following: "is entitled to—
14	"(1) one month of educational assistance bene-
15	fits under this chapter—
16	"(A) in the case of an individual described
17	in section 3012(a)(1)(A) of this title, for each
18	month of continuous active duty served by such
19	individual after June 30, 1985, as part of the
20	obligated period of active duty on which such
21	entitlement is based;
22	"(B) in the case of an individual described
23	in section 3012(a)(1)(B) of this title, for each
24	month of continuous active duty served by such
25	individual after June 30, 1985; or

1	"(C) in the case of an individual described
2	in section 3012(a)(1)(D) of this title, for each
3	month of active duty served by such individual
4	after September 11, 2001, as part of the aggre-
5	gate period of active duty on which such entitle-
6	ment is based; and
7	"(2) one month of educational assistance bene-
8	fits under this chapter for each four months served
9	by such individual in the Selected Reserve after the
10	applicable date specified in paragraph (1) (other
11	than any month in which the individual served on
12	active duty).".
13	(e) Amount of Assistance.—Section 3015 of such
14	title is amended—
15	(1) in subsections $(a)(1)(D)$ and $(b)(1)(D)$, by
16	striking "subsection (h)" and inserting "subsection
17	(i)";
18	(2) by redesignating subsection (h) as sub-
19	section (i); and
20	(3) by inserting after subsection (g) the fol-
21	lowing new subsection (h):
22	"(h) In the case of an individual entitled to an edu-
23	cational assistance allowance under section $3012(a)(1)(D)$
24	of this title, the amount of the basic educational assistance

- 1 allowance payable under this chapter is the amount deter-
- 2 mined under subsection (b) of this section.".
- 3 (d) Contribution.—Subsection (c) of section 3012
- 4 of such title is amended—
- 5 (1) in paragraph (1), by striking "paragraph
- 6 (2)" and inserting "paragraphs (2) and (3)";
- 7 (2) by redesignating paragraphs (2) and (3) as
- 8 paragraphs (3) and (4), respectively; and
- 9 (3) by inserting after paragraph (1) the fol-
- 10 lowing new paragraph:
- 11 "(2) The basic pay of any individual described in sub-
- 12 section (a)(1)(D) who does not make an election under
- 13 subsection (d)(1) shall be reduced by \$100 for each of the
- 14 first 12 months of active duty service (whether continuous
- 15 or otherwise) that such individual is entitled to such pay.".
- 16 (e) Election To Opt Out.—Subsection (d)(1) of
- 17 such section of such title is amended by striking "in sub-
- 18 section (a)(1)(A) of this section" and inserting "in sub-
- 19 section (a)(1)(A) or (a)(1)(D)".
- 20 (f) Outreach.—(1) The Secretaries concerned shall
- 21 take actions to inform members of the Selected Reserve
- 22 who are or may become entitled to basic educational as-
- 23 sistance benefits under chapter 30 of title 38, United
- 24 States Code, as a result of section 3012(a)(1)(D) of such
- 25 title (as amended by subsection (a) of this section) of the

- 1 minimum service requirements for entitlement to such
- 2 benefits under that chapter and of the scope and nature
- 3 of such benefits.
- 4 (2) In this subsection:
- 5 (A) The term "Secretary concerned" has the 6 meaning given such term in section 101(25) of title
- 7 38, United States Code.
- 8 (B) The term "Selected Reserve" has the 9 meaning given such term in section 3002(4) of title 10 38, United States Code.
