# A BILL

To amend the National Underground Railroad Network to Freedom Act of 1998 to provide additional staff and oversight of funds to carry out the Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### 1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "National Underground
- 3 Railroad Network to Freedom Reauthorization Act of
- 4 2007".

#### 5 SEC. 2. HIRING STAFF FOR THE NATIONAL UNDERGROUND

- 6 RAILROAD NETWORK.
- 7 Section 3 of the National Underground Railroad Net-
- 8 work to Freedom Act of 1998 (16 U.S.C. 469l-1) is
- 9 amended by striking subsection (d) and adding at the end
- 10 the following new subsection:
- 11 "(d) Staff.—The Secretary shall appoint at least 8
- 12 full time equivalent staff to assist the Secretary in car-
- 13 rying out the duties required by the Act, including pro-
- 14 viding oversight of the grant program established in sec-
- 15 tion 4.".
- 16 SEC. 3. AUTHORIZING APPROPRIATIONS FOR SPECIFIC
- 17 **PURPOSES.**
- 18 The National Underground Railroad Network to
- 19 Freedom Act of 1998 (16 U.S.C. 469l et seq.) is amend-
- 20 ed—
- 21 (1) by striking section 4(d); and
- 22 (2) by adding at the end the following new sec-
- 23 tion:

### 1 "SEC. 5. AUTHORIZATION OF APPROPRIATIONS.

- 2 "(a) Amounts.—There are authorized to be appro-
- 3 priated to carry out this Act \$2,500,000 for each fiscal
- 4 year, to be allocated as follows:
- 5 "(1) \$2,000,000 is to be used for the purposes
- 6 of section 3.
- 7 "(2) \$500,000 is to be used for the purposes of
- 8 section 4.
- 9 "(b) Restrictions.—No amounts may be appro-
- 10 priated for the purposes of this Act except to the Secretary
- 11 for carrying out the responsibilities of the Secretary as
- 12 set forth in this Act.
- 13 "(c) CARRY OVER.—Amounts appropriated pursuant
- 14 to the authorization of appropriations under subsection (a)
- 15 shall remain available until expended.".
- 16 SEC. 4. EFFECTIVE DATE.
- 17 The amendments made by sections 2 and 3 shall take
- 18 effect at the beginning of the next fiscal year following
- 19 the date of enactment of this Act.
