| 8 | (a) In General.—Subtitle H of title VIII of the |

| 12 | CURITY MISSIONS. |
| 13 | "(a) In General.—The Secretary shall seek to enter |
| 14 | into memoranda of understanding or other agreements |
| 15 | with the Secretary of Defense to use Civil Air Patrol per- |
| 16 | sonnel and resources to support homeland security mis- |
| 17 | sions in accordance with this section. |
| 18 | "(b) Use of Assets.—Pursuant to a memorandum |
| 19 | of understanding or other agreement entered into under |
| 20 | subsection (a), the Secretary may consider the use of Civil |
| 21 | Air Patrol personnel and resources for— |
| 22 | "(1) providing aerial reconnaissance or commu- |
| 23 | nications capabilities to the Border Patrol to protect |
| 24 | against illegal entry and trafficking in goods, cur- |
| 25 | rency, people, and other substances; |

- 1 "(2) providing capabilities to respond to an act
- 2 of terrorism, natural disaster, or other man-made
- 3 event, by assisting in damage assessment and situa-
- 4 tional awareness, conducting search and rescue oper-
- 5 ations, assisting in evacuations, transporting time-
- 6 sensitive medical or other materials; or
- 7 "(3) such other activities as the Secretary may
- 8 determine in coordination with the Secretary of De-
- 9 fense.
- 10 "(c) Inclusion in National Planning Activi-
- 11 TIES.—Pursuant to a memorandum of understanding or
- 12 other agreement entered into under subsection (a), the
- 13 Secretary shall consider the Civil Air Patrol as an avail-
- 14 able resource for purposes of national preparedness and
- 15 response planning activities, including the National Re-
- 16 sponse Plan.
- 17 "(d) Reimbursement.—A memorandum of under-
- 18 standing or other agreement entered into under subsection
- 19 (a) shall include a provision addressing the manner in
- 20 which the Department of Defense is to be reimbursed for
- 21 costs associated with the use of Civil Air Patrol personnel
- 22 or resources for homeland security purposes.".
- 23 (b) Report.—Not later than six months after the
- 24 date of the enactment of this Act, the Secretary of Home-
- 25 land Security and the Secretary of Defense shall submit

- 1 to the Committee on Homeland Security of the House of
- 2 Representatives and the Committee on Homeland Security
- 3 and Governmental Affairs of the Senate a report on the
- 4 status of any memorandum of understanding or other
- 5 agreement authorized under section 890A of the Home-
- 6 land Security Act, as added by subsection (a).
- 7 (c) Clerical Amendment.—The table of contents
- 8 in section 1(b) of such Act is amended by adding at the
- 9 end of the items relating to such subtitle the following: "Sec. 890A. Civil Air Patrol support of homeland security missions.".
