Mr. GENE GREEN of Texas introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To amend title 10, United States Code, to require the amounts reimbursed to institutional providers of health care services under the TRICARE program to be the same as amounts reimbursed under Medicare, and to require the Secretary of Defense to contract for health care services with at least one teaching hospital in urban areas.

1 **SECTION 1. REQUIREMENT FOR TRICARE PROGRAM REIM-**
2 **BURSEMENT OF INSTITUTIONAL PROVIDERS**
3 **OF HEALTH CARE SERVICES TO BE IDEN-**
4 **TICAL TO REIMBURSEMENT UNDER MEDI-**
5 **CARE.**

6 Section 1079(j)(2) of title 10, United States Code,
7 is amended by striking “determined to the extent prac-
8 ticable in accordance with the same reimbursement rules
9 as apply to payments to” and inserting “identical to the
10 amount of payments that would be paid to”.

11 **SEC. 2. REQUIREMENT FOR TRICARE PROGRAM TO CON-**
12 **TRACT WITH AT LEAST ONE TEACHING HOS-**
13 **PITAL IN URBAN AREAS FOR DELIVERY OF**
14 **HEALTH CARE.**

15 Section 1097(a) of title 10, United States Code, is
16 amended—

17 (1) by inserting “(1)” before “The Secretary of
18 Defense”;

19 (2) in the second sentence, by striking “The”
20 and inserting “Subject to paragraph (2), the”;

21 (3) by redesignating paragraphs (1), (2), (3),
22 and (4) as subparagraphs (A), (B), (C), and (D), re-
23 spectively; and

24 (4) by adding at the end the following new
25 paragraph:

1 “(2) In contracting for the delivery of health care
2 under this section, the Secretary shall contract with at
3 least one teaching hospital in each large urban area. In
4 this paragraph—

5 “(A) the term ‘teaching hospital’ means a hos-
6 pital which has a teaching program approved as
7 specified in section 1861(b)(6) of the Social Security
8 Act (42 U.S.C. 1395x(b)(6)); and

9 “(B) the term ‘large urban area’ has the mean-
10 ing given that term in the second sentence of section
11 1886(d)(2)(D) of the Social Security Act (42 U.S.C.
12 1395ww(d)(2)(D)).”.
