## A BILL

To include costs incurred by the Indian Health Service, a federally qualified health center, an AIDS drug assistance program, certain hospitals, or a pharmaceutical manufacturer patient assistance program in providing prescription drugs toward the annual out of pocket threshold under part D of title XVIII of the Social Security Act and to provide a safe harbor for assistance

provided under a pharmaceutical manufacturer patient assistance program.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Helping Fill the Medi-  
 5 care Rx Gap Act of 2007”.

6 **SEC. 2. INCLUDING COSTS INCURRED BY THE INDIAN**  
 7 **HEALTH SERVICE, A FEDERALLY QUALIFIED**  
 8 **HEALTH CENTER, AN AIDS DRUG ASSISTANCE**  
 9 **PROGRAM, CERTAIN HOSPITALS, OR A PHAR-**  
 10 **MACEUTICAL MANUFACTURER PATIENT AS-**  
 11 **SISTANCE PROGRAM IN PROVIDING PRE-**  
 12 **SCRIPTION DRUGS TOWARD THE ANNUAL**  
 13 **OUT OF POCKET THRESHOLD UNDER PART D.**

14 (a) IN GENERAL.—Section 1860D–2(b)(4)(C) of the  
 15 Social Security Act (42 U.S.C. 1395w–102(b)(4)(C)) is  
 16 amended—

17 (1) in clause (i), by striking “and” at the end;  
 18 (2) in clause (ii)—

19 (A) by striking “such costs shall be treated  
 20 as incurred only if” and inserting “subject to  
 21 clause (iii), such costs shall be treated as in-  
 22 curred if”;

1 (B) by striking “, under section 1860D–  
2 14, or under a State Pharmaceutical Assistance  
3 Program”; and

4 (C) by striking the period at the end and  
5 inserting “; and”; and

6 (3) by inserting after clause (ii) the following  
7 new clause:

8 “(iii) such costs shall be treated as in-  
9 curred and shall not be considered to be  
10 reimbursed under clause (ii) if such costs  
11 are borne or paid—

12 “(I) under section 1860D–14;

13 “(II) under a State Pharma-  
14 ceutical Assistance Program;

15 “(III) by the Indian Health Serv-  
16 ice, an Indian tribe or tribal organiza-  
17 tion, or an urban Indian organization  
18 (as defined in section 4 of the Indian  
19 Health Care Improvement Act);

20 “(IV) by a federally qualified  
21 health center (as defined in section  
22 1861(aa)(4));

23 “(V) under an AIDS Drug As-  
24 sistance Program under part B of

1 title XXVI of the Public Health Serv-  
2 ice Act;

3 “(VI) by a subsection (d) hos-  
4 pital (as defined in section  
5 1886(d)(1)(B)) that meets the re-  
6 quirements of clauses (i) and (ii) of  
7 section 340B(a)(4)(L) of the Public  
8 Health Service Act; or

9 “(VII) by a pharmaceutical man-  
10 ufacturer patient assistance program,  
11 either directly or through the distribu-  
12 tion or donation of covered part D  
13 drugs, which shall be valued at the  
14 negotiated price of such covered part  
15 D drug under the enrollee’s prescrip-  
16 tion drug plan or MA–PD plan as of  
17 the date that the drug was distributed  
18 or donated.”.

19 (b) EFFECTIVE DATE.—The amendments made by  
20 subsection (a) shall apply to costs incurred on or after  
21 January 1, 2007.

1 **SEC. 3. PROVIDING A SAFE HARBOR FOR PHARMA-**  
2 **CEUTICAL MANUFACTURER PATIENT ASSIST-**  
3 **ANCE PROGRAMS.**

4 (a) SAFE HARBOR.—Section 1128B(b)(3) of the So-  
5 cial Security Act (42 U.S.C. 1320a–7b(b)(3)) is amend-  
6 ed—

7 (1) in subparagraph (G), by striking “and” at  
8 the end;

9 (2) in subparagraph (H), as added by section  
10 237(d) of the Medicare Prescription Drug, Improve-  
11 ment, and Modernization Act of 2003 (Public Law  
12 108–173; 117 Stat. 2213)—

13 (A) by moving such subparagraph 2 ems to  
14 the left; and

15 (B) by striking the period at the end and  
16 inserting a semicolon;

17 (3) by redesignating subparagraph (H), as  
18 added by section 431(a) of the Medicare Prescrip-  
19 tion Drug, Improvement, and Modernization Act of  
20 2003 (Public Law 108–173; 117 Stat. 2287), as  
21 subparagraph (I);

22 (4) in subparagraph (I), as so redesignated—

23 (A) by moving such subparagraph 2 ems to  
24 the left; and

25 (B) by striking the period at the end and  
26 inserting “; and”; and

1           (5) by adding at the end the following new sub-  
2       paragraph:

3           “(J) any remuneration paid by a pharma-  
4       ceutical manufacturer patient assistance program,  
5       either in cash or through the distribution or dona-  
6       tion of covered Part D drugs (as defined in section  
7       1860D–2(e)), to an individual enrolled in a prescrip-  
8       tion drug plan under part D of title XVIII or in an  
9       MA–PD plan under part C of such title.”.

10       (b) EFFECTIVE DATE.—The amendments made by  
11       subsection (a) shall apply to remuneration paid on or after  
12       January 1, 2007.
