6 SEC. 2. REDUCTION IN RATE OF TENTATIVE MINIMUM TAX 7 FOR NONCORPORATE TAXPAYERS.

- 8 (a) IN GENERAL.—Clause (i) of section 55(b)(1)(A)
- 9 of the Internal Revenue Code of 1986 (relating to noncor-
- 10 porate taxpayers) is amended to read as follows:

"(i) IN GENERAL.—In the case of a 1 2 taxpayer other than a corporation, the ten-3 tative minimum tax for the taxable year is— 4 "(I) 24 percent of the taxable ex-5 cess, reduced by 6 "(II) the alternative minimum 7 tax foreign tax credit for the taxable 8 9 year.". 10 (b) CONFORMING AMENDMENT.—Subparagraph (A) of section 55(b)(1) of such Code is amended by striking 11 clause (iii). 12
