AN ACT

To amend the Compact of Free Association Amendments Act of 2003, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Compacts of Free As-
- 5 sociation Amendments Act of 2007".
- 6 SEC. 2. APPROVAL OF AGREEMENTS.
- 7 (a) IN GENERAL.—Section 101 of the Compact of
- 8 Free Association Amendments Act of 2003 (48 U.S.C.
- 9 1921) is amended—

- 25 Amendments Act of 2003 shall be available to both the

United States Agency for International Development and the Federal Emergency Management Agency to facilitate 3 each agency's activities under the Federal Programs and 4 Services Agreements. SEC. 4.
