To amend title 38, United States Code, to establish the position of Director of Physician Assistant Services with-

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ESTABLISHMENT OF DIRECTOR OF PHYSICIAN**
4 **ASSISTANT SERVICES AT VETERANS HEALTH**
5 **ADMINISTRATION OF DEPARTMENT OF VET-**
6 **ERANS AFFAIRS.**

7 Section 7306(a) of title 38, United States Code, is
8 amended by striking paragraph (9) and inserting the fol-
9 lowing new paragraph (9):

10 “(9) The Director of Physician Assistant Serv-
11 ices, who shall be a qualified physician assistant who
12 shall report to the Under Secretary for Health on all
13 matters relating to the education and training, em-
14 ployment, appropriate utilization, and optimal par-
15 ticipation of physician assistants within the pro-
16 grams and initiatives of the Administration. The Di-
17 rector of Physician Assistant Services shall serve in
18 a full-time capacity at the Central Office of the De-
19 partment.”.

5 (a) *IN GENERAL.*—Section 7306(a) of title 38, United
6 States Code, is amended by striking paragraph (9) and in-
7 serting the following:

8 “(9) *The Director of Physician Assistant Serv-*
9 *ices, who shall be a qualified physician assistant who*
10 *shall report to the Under Secretary for Health on all*
11 *matters relating to the education and training, em-*
12 *ployment, appropriate utilization, and optimal par-*
13 *ticipation of physician assistants within the pro-*
14 *grams and initiatives of the Administration. The Di-*
15 *rector of Physician Assistant Services shall serve in*
16 *a full-time capacity at the Central Office of the De-*
17 *partment.”.*

18 (b) *DEADLINE FOR IMPLEMENTATION.*—The Secretary
19 of Veterans Affairs shall ensure that an individual is serv-
20 ing as the Director of Physician Assistant Services under
21 section 7306(a)(9) of title 38, United States Code, as added
22 by subsection (a), by not later than 120 days after the date
23 of the enactment of this Act.
