## A BILL

To amend title 38, United States Code, to provide for the establishment of Epilepsy Centers of Excellence in the Veterans Health Administration of the Department of Veterans Affairs.

1        *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Veterans’ Epilepsy*  
 5 *Treatment Act of 2008”.*

6        **SEC. 2. EPILEPSY CENTERS OF EXCELLENCE.**

7        *(a) REQUIREMENT FOR ESTABLISHMENT OF EPILEPSY*  
 8 *CENTERS OF EXCELLENCE.—Subchapter II of chapter 73*

1 of title 38, United States Code, is amended by adding at  
2 the end the following new section:

3 **“§ 7330A. Epilepsy centers of excellence**

4 “(a) *DESIGNATION OF CENTERS.*—Not later than 120  
5 days after the date of enactment of this section, the Sec-  
6 retary shall designate an epilepsy center of excellence at  
7 each of the 5 centers designated under section 7327.

8 “(b) *EXPERT CLINICAL AND RESEARCH STAFF.*—Each  
9 center designated under subsection (a) shall employ such  
10 expert clinical and research staff, including board certified  
11 neurologists and neurosurgeons, as may be necessary to en-  
12 sure that such center is capable of serving as a center of  
13 excellence in research, education, and clinical care activities  
14 in the diagnosis and treatment of epilepsy, including post-  
15 traumatic epilepsy.

16 “(c) *REQUIREMENTS AND OPERATION OF CENTERS.*—  
17 Each center designated under subsection (a) shall function  
18 as a center for—

19 “(1) research on the diagnosis, treatment, and  
20 long-term effects of epilepsy, including epilepsy devel-  
21 oped as a result of combat, in order to support the  
22 provision of services for such diagnosis and treatment  
23 in accordance with the most current information on  
24 epilepsy;

1           “(2) the development of evidence-based meth-  
2           odologies for treating individuals with epilepsy;

3           “(3) the continuous and consistent coordination  
4           of care from the point of referral throughout the diag-  
5           nostic and treatment process and ongoing follow-up  
6           after return to home and community;

7           “(4) the development of a national system of co-  
8           ordinated care for veterans with epilepsy, including  
9           the development and maintenance of a national net-  
10          work of Department health care personnel with an in-  
11          terest and expertise in the care and treatment of epi-  
12          lepsy and the establishment of a referral system and  
13          procedure within each Veterans Integrated Service  
14          Network;

15          “(5) assist in the expansion, where appropriate,  
16          of the utilization of telehealth technology, including  
17          exploring the use of such technology to develop, trans-  
18          mit, monitor, and review neurological diagnostic tests  
19          and other applicable uses of telehealth technology for  
20          the diagnosis, care, and treatment of veterans with  
21          epilepsy; and

22          “(6) the dissemination of educational materials  
23          and research regarding diagnosis, care, and treatment  
24          of epilepsy, throughout the Department.

1       “(d) *ADMINISTRATION.*—*In order to assist the Sec-*  
2 *retary in carrying out this section, the Secretary shall des-*  
3 *ignate a national coordinator for epilepsy programs who*  
4 *shall report to the official responsible for neurology at the*  
5 *Veterans Health Administration and shall—*

6               “(1) *supervise the operation of the centers des-*  
7 *ignated under this section;*

8               “(2) *coordinate and support the national net-*  
9 *work of Department health care professionals with an*  
10 *interest and expertise in the care and treatment of*  
11 *epilepsy;*

12               “(3) *ensure that the education and research mis-*  
13 *sion of such centers is being accomplished; and*

14               “(4) *conduct regular evaluations of such centers*  
15 *to ensure compliance with the requirements of this*  
16 *section.*

17       “(e) *AUTHORIZATION OF APPROPRIATIONS.*—*There is*  
18 *authorized to be appropriated to carry out this section*  
19 *\$5,000,000 for each of fiscal years 2009 through 2013.”.*

20       “(b) *CLERICAL AMENDMENT.*—*The table of sections at*  
21 *the beginning of such chapter is amended by inserting after*  
22 *the item relating to section 7330 the following new item:*  
*“7330A. Epilepsy centers of excellence.”.*

Amend the title so as to read: “A bill to amend title  
38, United States Code, to provide for the establishment

of epilepsy centers of excellence in the Veterans Health Administration of the Department of Veterans Affairs.”.
