1 **TITLE I—AMENDMENTS TO NA-**
 2 **TIONAL AND COMMUNITY**
 3 **SERVICE ACT OF 1990**

4 **SEC. 1001. REFERENCES.**

5 *Except as otherwise specifically provided, whenever in*
 6 *this title an amendment or repeal is expressed in terms of*
 7 *an amendment to, or repeal of, a provision, the reference*
 8 *shall be considered to be made to a provision of the National*
 9 *and Community Service Act of 1990 (42 U.S.C. 12501 et*
 10 *seq.).*

11 **Subtitle A—Amendments to Subtitle**
 12 **A (General Provisions)**

13 **SEC. 1101. PURPOSES; SENSE OF CONGRESS.**

14 *(a) PURPOSES.—Section 2(b) (42 U.S.C. 12501(b)) is*
 15 *amended—*

16 *(1) in paragraph (2), by striking “community*
 17 *throughout” and inserting “community and service*
 18 *throughout the varied and diverse communities of”;*

1 (2) in paragraph (4), by inserting after “in-
2 come,” the following: “geographic location,”;

3 (3) in paragraph (6), by inserting after “exist-
4 ing” the following: “national”;

5 (4) in paragraph (7)—

6 (A) by striking “programs and agencies”
7 and inserting “programs, agencies, and commu-
8 nities”; and

9 (B) by striking “and” at the end;

10 (5) in paragraph (8), by striking the period and
11 inserting a semicolon; and

12 (6) by adding at the end the following:

13 “(9) expand and strengthen service-learning pro-
14 grams through year-round opportunities, including
15 during the summer months, to improve the education
16 of children and youth and to maximize the benefits of
17 national and community service, in order to renew
18 the ethic of civic responsibility and the spirit of com-
19 munity to children and youth throughout the United
20 States;

21 “(10) assist in coordinating and strengthening
22 Federal and other citizen service opportunities, in-
23 cluding opportunities for participation in emergency
24 and disaster preparedness, relief, and recovery;

1 “(11) increase service opportunities for our Na-
2 tion’s retiring professionals, including such opportu-
3 nities for those retiring from the science, technical,
4 engineering, and mathematics professions to improve
5 the education of our Nation’s youth and keep America
6 competitive in the global knowledge economy, and to
7 further utilize the experience, knowledge, and skills of
8 older Americans;

9 “(12) encourage the continued service of the
10 alumni of the national service programs, including
11 service in times of national need; and

12 “(13) encourage members of the Baby Boom gen-
13 eration to partake in service opportunities.”.

14 (b) *SENSE OF CONGRESS.*—The Act is amended by in-
15 serting after section 2 the following:

16 **“SEC. 3. SENSE OF CONGRESS.**

17 *“It is the sense of Congress that the number of partici-
18 pants in the AmeriCorps programs, including the Volun-
19 teers in Service to America (VISTA) and the National Ci-
20 vilian Community Corps (NCCC), should grow to reach
21 100,000 participants by 2012.”.*

22 **SEC. 1102. DEFINITIONS.**

23 Section 101 (42 U.S.C. 12511) is amended—

24 (1) by redesignating—

1 (A) paragraphs (21) through (29) as para-
2 graphs (28) through (36), respectively;

3 (B) paragraphs (9) through (20) as para-
4 graphs (15) through (26), respectively; and

5 (C) paragraphs (7) and (8) as paragraphs
6 (10) and (11), respectively; and

7 (D) paragraphs (3) through (6) as para-
8 graphs (5) through (8), respectively;

9 (2) by inserting after paragraph (2) the fol-
10 lowing:

11 “(3) *APPROVED SUMMER OF SERVICE POSI-*
12 *TION.—The term ‘approved summer of service posi-*
13 *tion’ means a position in a program described under*
14 *section 111(a)(5) for which the Corporation has ap-*
15 *proved the provision of a summer of service edu-*
16 *cational award as one of the benefits to be provided*
17 *for successful service in the position.*”

18 “(4) *BABY BOOM GENERATION.—The term ‘Baby*
19 *Boom generation’ means the generation that consists*
20 *of individuals born during the period beginning with*
21 *1946 and ending with 1964.”;*

22 (3) in paragraph (5) (as so redesignated), by
23 striking “described in section 122”;

24 (4) in paragraph (7) (as so redesignated), by
25 striking “church or other”;

1 (5) by inserting after paragraph (8) (as so rededesignated) the following:

2 “(9) *DISADVANTAGED YOUTH*.—The term ‘disadvantaged youth’ includes those youth who are economically disadvantaged and one or more of the following:

3 “(A) Who are out-of-school youth, including out-of-school youth who are unemployed.

4 “(B) Who are in or aging out of foster care.

5 “(C) Who have limited English proficiency.

6 “(D) Who are homeless or who have run away from home.

7 “(E) Who are at-risk to leave school without a diploma.

8 “(F) Who are former juvenile offenders or at risk of delinquency.”;

9 (6) by inserting after paragraph (11) (as so redesignated) the following:

10 “(12) *GRANTMAKING ENTITY*.—The term ‘grantmaking entity’ means a public or private nonprofit organization that—

11 “(A) has experience with service-learning or with meeting unmet human, educational, environmental, or public safety needs;

1 “(B) was in existence at least one year be-
2 fore the date on which the organization sub-
3 mitted an application under the national service
4 laws; and

5 “(C) meets other such criteria as the Chief
6 Executive Officer may establish.

7 “(13) *HISPANIC-SERVING INSTITUTION*.—The
8 term ‘Hispanic-serving institution’ has the meaning
9 given the term in section 502(a) of the Higher Edu-
10 cation Act of 1965 (20 U.S.C. 1101a(a)).

11 “(14) *HISTORICALLY BLACK COLLEGE OR UNI-*
12 *VERSITY*.—The term ‘historically black college or uni-
13 versity’ means a part B institution, as defined in sec-
14 tion 322 of the Higher Education Act of 1965 (20
15 U.S.C. 1101a(a)).”;

16 (7) in paragraph (19) (as so redesignated), by
17 striking “section 101(a) of the Higher Education Act
18 of 1965” and inserting “sections 101(a) and
19 102(a)(1) of the Higher Education Act of 1965”;

20 (8) in paragraph (23)(B) (as so redesignated),
21 by striking “program in which the participant is en-
22 rolled” and inserting “organization receiving assist-
23 ance under the national service laws through which
24 the participant is enrolled in an approved national
25 service position”;

1 (9) by inserting after paragraph (26) (as so re-
2 designated) the following:

3 “(27) **QUALIFIED ORGANIZATION.**—The term
4 ‘qualified organization’ means a public or private
5 nonprofit organization with experience working with
6 school-age youth that meets such criteria as the Chief
7 Executive Officer may establish.”; and

8 (10) by adding at the end the following:

9 “(37) **TRIBALLY CONTROLLED COLLEGE OR UNI-**
10 **VERSITY.**—The term ‘tribally controlled college or
11 university’ has the meaning given in section 2 of the
12 Tribally Controlled College or University Assistance
13 Act of 1978 (25 U.S.C. 1801).”.

14 **Subtitle B—Amendments to Subtitle**
15 **B (Service-Learning)**

16 **SEC. 1201. SCHOOL-BASED ALLOTMENTS.**

17 Part I of subtitle B of title I (42 U.S.C. 12521 et seq.)
18 is amended to read as follows:

19 **“PART I—PROGRAMS FOR ELEMENTARY AND**
20 **SECONDARY STUDENTS**

21 **“SEC. 111. ASSISTANCE TO STATES, TERRITORIES, AND IN-**
22 **DIAN TRIBES.**

23 “(a) **ALLOTMENTS TO STATES, TERRITORIES, AND IN-**
24 **DIAN TRIBES.**—The Corporation, in consultation with the
25 Secretary of Education, may make allotments to State edu-

1 *cational agencies, Territories, and Indian tribes to pay for*
2 *the Federal share of—*

3 “(1) *planning and building the capacity within*
4 *the State, Territory, or Indian tribe to implement*
5 *service-learning programs that are based principally*
6 *in elementary and secondary schools, including—*

7 “(A) *providing training for teachers, super-*
8 *visors, personnel from community-based agencies*
9 *(particularly with regard to the recruitment, uti-*
10 *lization, and management of participants), and*
11 *trainers, to be conducted by qualified individuals*
12 *or organizations that have experience with serv-*
13 *ice-learning;*

14 “(B) *developing service-learning curricula,*
15 *consistent with State or local academic content*
16 *standards, to be integrated into academic pro-*
17 *grams, including an age-appropriate learning*
18 *component that provides participants an oppor-*
19 *tunity to analyze and apply their service experi-*
20 *ences;*

21 “(C) *forming local partnerships described in*
22 *paragraph (2) or (4) to develop school-based*
23 *service-learning programs in accordance with*
24 *this part;*

1 “(D) devising appropriate methods for re-
2 search and evaluation of the educational value of
3 service-learning and the effect of service-learning
4 activities on communities;

5 “(E) establishing effective outreach and dis-
6 semination of information to ensure the broadest
7 possible involvement of community-based agen-
8 cies with demonstrated effectiveness in working
9 with school-age youth in their communities; and

10 “(F) establishing effective outreach and dis-
11 semination of information to ensure the broadest
12 possible participation of schools throughout the
13 State, with particular attention to schools identi-
14 fied for school improvement under title I of the
15 Elementary and Secondary Education Act of
16 1965 (20 U.S.C. 6301 et seq.);

17 “(2) implementing, operating, or expanding
18 school-based service-learning programs, which may
19 include paying for the cost of the recruitment, train-
20 ing, supervision, placement, salaries, and benefits of
21 service-learning coordinators, through distribution of
22 Federal funds by State educational agencies, Terri-
23 tories, and Indian tribes made available under this
24 part to projects operated by local partnerships
25 among—

1 “(A) local educational agencies; and
2 “(B) 1 or more community partners that—
3 “(i) shall include a public or private
4 nonprofit organization that—
5 “(I) has a demonstrated expertise
6 in the provision of services to meet
7 unmet human, education, environ-
8 mental, or public safety needs;
9 “(II) will make projects available
10 for participants, who shall be students;
11 and
12 “(III) was in existence at least 1
13 year before the date on which the orga-
14 nization submitted an application
15 under section 113; and
16 “(ii) may include a private for-profit
17 business, private elementary or secondary
18 school, or Indian tribe (except that an In-
19 dian tribe distributing funds to a project
20 under this paragraph is not eligible to be
21 part of the partnership operating that
22 project);
23 “(3) planning of school-based service-learning
24 programs, through distribution by State educational
25 agencies, Territories, and Indian tribes of Federal

1 *funds made available under this part to local edu-*
2 *cational agencies and Indian tribes, which planning*
3 *may include paying for the cost of—*

4 *“(A) the salaries and benefits of service-*
5 *learning coordinators; or*

6 *“(B) the recruitment, training, supervision,*
7 *and placement of service-learning coordinators*
8 *who may be participants in a program under*
9 *subtitle C or receive a national service edu-*
10 *cational award under subtitle D, who may be*
11 *participants in a project under section 201 of the*
12 *Domestic Volunteer Service Act of 1973 (42*
13 *U.S.C. 5001), or who may participate in a*
14 *Youthbuild program under section 173A of the*
15 *Workforce Investment Act of 1998 (29 U.S.C.*
16 *2918a),*

17 *who will identify the community partners described*
18 *in paragraph (2)(B) and assist in the design and im-*
19 *plementation of a program described in paragraph*
20 *(2);*

21 *“(4) implementing, operating, or expanding*
22 *school-based service-learning programs to utilize adult*
23 *volunteers in service-learning to improve the edu-*
24 *cation of students, through distribution by State edu-*

1 *cational agencies, Territories, and Indian tribes of*
2 *Federal funds made available under this part to—*

3 *“(A) local educational agencies;*

4 *“(B) Indian tribes (except that an Indian*
5 *tribe distributing funds under this paragraph is*
6 *not eligible to be a recipient of those funds);*

7 *“(C) public or private nonprofit organiza-*
8 *tions; or*

9 *“(D) partnerships or combinations of local*
10 *educational agencies and entities described in*
11 *subparagraph (B) or (C); and*

12 *“(5) establishing or implementing summer of*
13 *service programs during the summer months, includ-*
14 *ing the cost of recruitment, training, and placement*
15 *of service-learning coordinators—*

16 *“(A) for youth who will be enrolled in any*
17 *grade from grade 6 through grade 12 at the end*
18 *of the summer concerned;*

19 *“(B) for community-based service-learning*
20 *projects that—*

21 *“(i) shall—*

22 *“(I) meet unmet human, edu-*
23 *cational, environmental (including en-*
24 *ergy conservation and stewardship),*

1 *emergency and disaster preparedness,*
2 *and public service needs; and*

3 *“(II) be intensive, structured, su-*
4 *pervised, and designed to produce iden-*
5 *tifiable improvements to the commu-*
6 *nity; and*

7 *“(ii) may include the extension of aca-*
8 *demic year service-learning programs into*
9 *the summer months;*

10 *“(C) through the distribution of Federal*
11 *funds made available under this part to projects*
12 *operated by local partnerships that consist of*
13 *local educational agencies and—*

14 *“(i) public or private elementary*
15 *schools or secondary schools;*

16 *“(ii) institutions of higher education;*

17 *“(iii) public or private non-profit or-*
18 *ganizations that—*

19 *“(I) have a demonstrated expertise*
20 *in providing services to meet unmet*
21 *human, educational, environmental, or*
22 *public safety needs; and*

23 *“(II) have been in existence for at*
24 *least 1 year before the date on which*

1 *the organization submitted an applica-*
2 *tion under section 113;*

3 *“(iv) for-profit businesses; or*

4 *“(v) a consortia of such entities;*

5 *“(D) under which any student who com-*
6 *pletes 100 hours of service in an approved sum-*
7 *mer of service position, as certified through a*
8 *process determined by the Corporation through*
9 *regulations consistent with section 139(f), shall*
10 *be eligible for a summer of service educational*
11 *award of not more than \$500 (or, at the discre-*
12 *tion of the Chief Executive Officer, not more*
13 *than \$1,000 in the case of a participant who is*
14 *economically disadvantaged) from funds depos-*
15 *ited in the National Service Trust and distrib-*
16 *uted by the Corporation as described in section*
17 *148; and*

18 *“(E) subject to the limitation that a student*
19 *may not receive more than 2 summer of service*
20 *educational awards from funds deposited in the*
21 *National Service Trust.*

22 *“(b) PROGRAMS TO ENCOURAGE CIVIC ENGAGEMENT*
23 *IN SERVICE LEARNING.—*

24 *“(1) IN GENERAL.—From funds appropriated*
25 *under section 501(a)(1), and without regard to sec-*

1 *tion 112(b), the Corporation shall reserve up to 3 per-*
2 *cent for competitive grants to partnerships described*
3 *in subsection (a)(2) for the development of service-*
4 *learning programs that promote greater civic engage-*
5 *ment among elementary and secondary school stu-*
6 *dents.*

7 *“(2) APPLICATION.—To be eligible to receive a*
8 *grant under this subsection, a partnership shall sub-*
9 *mit an application at such time, in such manner,*
10 *and containing such information as the Corporation*
11 *may require.*

12 *“(3) ACTIVITIES.—Partnerships receiving grants*
13 *under this subsection shall use funds to develop serv-*
14 *ice-learning curricula that—*

15 *“(A) promote a better understanding of the*
16 *principles of the Constitution of the United*
17 *States, the heroes of American history (including*
18 *military heroes), and the meaning of the Oath of*
19 *Allegiance;*

20 *“(B) promote a better understanding of how*
21 *the Nation’s government functions; and*

22 *“(C) promote a better understanding of the*
23 *importance of service in the Nation’s character.*

24 *“(c) DUTIES OF SERVICE-LEARNING COORDINATOR.—*
25 *A service-learning coordinator referred to in paragraph (2),*

1 (3), or (5) of subsection (a) shall provide services that may
2 include—

3 “(1) providing technical assistance and informa-
4 tion to, and facilitating the training of, teachers and
5 assisting in the planning, development, execution, and
6 evaluation of service-learning in their classrooms;

7 “(2) assisting local partnerships described in
8 subsection (a) in the planning, development, and exe-
9 cution of service-learning projects, including summer
10 of service programs; and

11 “(3) carrying out such other duties as the recipi-
12 ent of assistance under this part may determine to be
13 appropriate.

14 “(d) *RELATED EXPENSES.*—An entity that receives fi-
15 nancial assistance under this part may, in carrying out
16 the activities described in subsection (a), use such assistance
17 to pay for the Federal share of reasonable costs related to
18 the supervision of participants, program administration,
19 transportation, insurance, and evaluations and for other
20 reasonable expenses related to the activities.

22 “(a) *INDIAN TRIBES AND TERRITORIES.*—Of the
23 amounts appropriated to carry out this part for any fiscal
24 year, the Corporation shall reserve an amount of not less
25 than 2 percent and not more than 3 percent for payments

1 *to Indian tribes, the United States Virgin Islands, Guam,*
2 *American Samoa, and the Commonwealth of the Northern*
3 *Mariana Islands, to be allotted in accordance with their*
4 *respective needs.*

5 “(b) *ALLOTMENTS THROUGH STATES.*—*After reserv-*
6 *ing the amount under subsection (a), the Corporation shall*
7 *use the remainder of the funds appropriated to carry out*
8 *this part for any fiscal year as follows:*

9 “(1) *ALLOTMENTS.*—

10 “(A) *SCHOOL-AGE YOUTH.*—*From 50 per-*
11 *cent of such remainder, the Corporation shall*
12 *allot to each State an amount that bears the*
13 *same ratio to 50 percent of such remainder as*
14 *the number of school-age youth in the State bears*
15 *to the total number of school-age youth of all*
16 *States.*

17 “(B) *ALLOCATION UNDER ELEMENTARY AND*
18 *SECONDARY EDUCATION ACT OF 1965.*—*From 50*
19 *percent of such remainder, the Corporation shall*
20 *allot to each State an amount that bears the*
21 *same ratio to 50 percent of such remainder as*
22 *the allocation to the State for the previous fiscal*
23 *year under title I of the Elementary and Sec-*
24 *ondary Education Act of 1965 (20 U.S.C. 6311*

1 *et seq.) or its successor authority bears to such*
2 *allocations to all States.*

3 “(2) *DEFINITION.*—*Notwithstanding section 101,*
4 *for purposes of this subsection, the term ‘State’ means*
5 *each of the several States, the District of Columbia,*
6 *and the Commonwealth of Puerto Rico.*

7 “(c) *REALLOTMENT.*—*If the Corporation determines*
8 *that the allotment of a State, Territory, or Indian tribe*
9 *under this section will not be required for a fiscal year be-*
10 *cause the State, Territory, or Indian tribe did not submit*
11 *and receive approval of an application for the allotment*
12 *under section 113, the Corporation shall make the allotment*
13 *for such State, Territory, or Indian tribe available for*
14 *grants to grantmaking entities to carry out service-learning*
15 *programs as described in section 111(a) in such State, Ter-*
16 *ritory, or Indian tribe. After grantmaking entities apply*
17 *for the allotment with an application at such time and in*
18 *such manner as the Corporation requires and receive ap-*
19 *proval, the remainder of such allotment shall be available*
20 *for reallocation to such other States, Territories, or Indian*
21 *tribes with approved applications submitted under section*
22 *113 as the Corporation may determine to be appropriate.*

23 **“SEC. 113. APPLICATIONS.**

24 “(a) *IN GENERAL.*—*To be eligible to receive an allot-*
25 *ment under section 112 or an allotment of approved sum-*

1 *mer of service positions under section 111(a)(5)(D), a State,*
2 *acting through the State educational agency, Territory, or*
3 *Indian tribe shall prepare, submit to the Corporation, and*
4 *obtain approval of, an application at such time and in such*
5 *manner as the Chief Executive Officer may reasonably re-*
6 *quire.*

7 “(b) *CONTENTS.—An application for an allotment*
8 *under this part shall include—*

9 “(1) *a proposal for a 3-year plan promoting*
10 *service-learning, which shall contain such information*
11 *as the Chief Executive Officer may reasonably re-*
12 *quire, including how the applicant will integrate*
13 *service opportunities into the academic program of*
14 *the participants;*

15 “(2) *information about the applicant’s efforts*
16 *to—*

17 “(A) *ensure that students of different ages,*
18 *racess, sexes, ethnic groups, disabilities, and eco-*
19 *nomic backgrounds have opportunities to serve*
20 *together;*

21 “(B) *include any opportunities for students*
22 *enrolled in schools or other programs of edu-*
23 *cation providing elementary or secondary edu-*
24 *cation to participate in service-learning pro-*
25 *grams and ensure that such service-learning pro-*

1 *grams include opportunities for such students to*
2 *serve together;*

3 “(C) *involve participants in the design and*
4 *operation of the program;*

5 “(D) *promote service-learning in areas of*
6 *greatest need, including low-income or rural*
7 *areas; and*

8 “(E) *otherwise integrate service opportuni-*
9 *ties into the academic program of the partici-*
10 *pants; and*

11 “(3) *assurances that the applicant will comply*
12 *with the nonduplication and nondisplacement re-*
13 *quirements of section 177 and the grievance proce-*
14 *dures required by section 176.*

15 “(c) *APPLICATION TO STATE, TERRITORY, OR INDIAN*
16 *TRIBE TO RECEIVE ASSISTANCE TO CARRY OUT SCHOOL-*
17 *BASED SERVICE-LEARNING PROGRAMS.—*

18 “(1) *IN GENERAL.—Any—*

19 “(A) *qualified organization, Indian tribe,*
20 *Territory, local educational agency, for-profit*
21 *business, private elementary, middle, or sec-*
22 *ondary school, or institution of higher education*
23 *that desires to receive financial assistance under*
24 *this subpart from a State, Territory, or Indian*

1 *tribe for an activity described in section*
2 *111(a)(1);*

3 “(B) *partnership described in section*
4 *111(a)(2) that desires to receive such assistance*
5 *from a State, Territory, or Indian tribe or*
6 *grantmaking entity described in section*
7 *111(a)(2);*

8 “(C) *entity described in section 111(a)(3)*
9 *that desires to receive such assistance from a*
10 *State, Territory, or Indian tribe for an activity*
11 *described in such section;*

12 “(D) *partnership described in section*
13 *111(a)(4) that desires to receive such assistance*
14 *from a State, Territory, or Indian tribe for an*
15 *activity described in such section;*

16 “(E) *agency or partnership described in sec-*
17 *tion 111(a)(5) that desires to receive such assist-*
18 *ance, or approved summer of service positions,*
19 *from a State, Territory, or Indian tribe for an*
20 *activity described in such section to be carried*
21 *out through a service-learning program described*
22 *in section 111,*

23 *shall prepare, submit to the State educational agency,*
24 *Territory, grantmaking entity, or Indian tribe, and*
25 *obtain approval of, an application for the program.*

1 “(2) *SUBMISSION.*—Such application shall be
2 submitted at such time and in such manner, and
3 shall contain such information, as the agency, Terri-
4 tory, Indian tribe, or entity may reasonably require.

5 “(d) *EXCEPTION.*—Notwithstanding subsections (a)
6 and (b) of section 112, if less than \$20,000,000 is appro-
7 priated for any fiscal year to carry out this part, the Cor-
8 poration shall award grants to States, Territories, and In-
9 dian tribes from the amount so appropriated, on a competi-
10 tive basis to pay for the Federal share of the activities de-
11 scribed in section 111.

12 **“SEC. 114. CONSIDERATION OF APPLICATIONS.**

13 “(a) *PRIORITY.*—In considering competitive applica-
14 tions under this part, the Corporation shall give priority
15 to innovation, sustainability, capacity building, involve-
16 ment of disadvantaged youth, and quality of programs, as
17 well as other criteria approved by the Chief Executive Offi-
18 cer.

19 “(b) *REJECTION OF APPLICATIONS.*—If the Corpora-
20 tion rejects an application submitted by a State under sec-
21 tion 113 for an allotment, the Corporation shall promptly
22 notify the State of the reasons for the rejection of the appli-
23 cation. The Corporation shall provide the State with a rea-
24 sonable opportunity to revise and resubmit the application
25 and shall provide technical assistance, if needed, to the

1 *State as part of the resubmission process. The Corporation*
2 *shall promptly reconsider such resubmitted application.*

3 **“SEC. 115. PARTICIPATION OF STUDENTS AND TEACHERS**
4 **FROM PRIVATE SCHOOLS.**

5 *“(a) IN GENERAL.—To the extent consistent with the*
6 *number of students in the State, Territory, or Indian tribe*
7 *or in the school district of the local educational agency in-*
8 *olved who are enrolled in private nonprofit elementary*
9 *and secondary schools, such State, Territory, Indian tribe,*
10 *or agency shall (after consultation with appropriate private*
11 *school representatives) make provision—*

12 *“(1) for the inclusion of services and arrange-*
13 *ments for the benefit of such students so as to allow*
14 *for the equitable participation of such students in the*
15 *programs implemented to carry out the objectives and*
16 *provide the benefits described in this part; and*

17 *“(2) for the training of the teachers of such stu-*
18 *dents so as to allow for the equitable participation of*
19 *such teachers in the programs implemented to carry*
20 *out the objectives and provide the benefits described in*
21 *this part.*

22 *“(b) WAIVER.—If a State, Territory, Indian tribe, or*
23 *local educational agency is prohibited by law from pro-*
24 *viding for the participation of students or teachers from*
25 *private nonprofit schools as required by subsection (a), or*

1 *if the Corporation determines that a State, Territory, In-*
2 *dian tribe, or local educational agency substantially fails*
3 *or is unwilling to provide for such participation on an eq-*
4 *uitable basis, the Chief Executive Officer shall waive such*
5 *requirements and shall arrange for the provision of services*
6 *to such students and teachers. Such waivers shall be subject*
7 *to the requirements of sections 9503 and 9504 of the Ele-*
8 *mentary and Secondary Education Act of 1965 (20 U.S.C.*
9 *7883 and 7884).*

10 **“SEC. 116. FEDERAL, STATE, AND LOCAL CONTRIBUTIONS.**

11 *“(a) FEDERAL SHARE.—*

12 *“(1) IN GENERAL.—The Federal share of the cost*
13 *of carrying out a program for which assistance is*
14 *provided under this part may not exceed 50 percent*
15 *of the total cost of the program.*

16 *“(2) NON-FEDERAL CONTRIBUTION.—In pro-*
17 *viding for the remaining share of the cost of carrying*
18 *out such a program, each recipient of assistance*
19 *under this part—*

20 *“(A) shall provide for such share through a*
21 *payment in cash or in kind, fairly evaluated, in-*
22 *cluding facilities, equipment, or services; and*

23 *“(B) may provide for such share through*
24 *State sources or local sources, including private*
25 *funds or donated services.*

1 “(b) *WAIVER.*—*The Chief Executive Officer may waive*
2 *the requirements of subsection (a) in whole or in part with*
3 *respect to any such program for any fiscal year if the Cor-*
4 *poration determines that such a waiver would be equitable*
5 *due to a lack of available financial resources at the local*
6 *level.*

7 “**SEC. 116A. LIMITATIONS ON USES OF FUNDS.**

8 “*Not more than 6 percent of the amount of assistance*
9 *received by an applicant in a fiscal year may be used to*
10 *pay, in accordance with such standards as the Corporation*
11 *may issue, for administrative costs, incurred by—*

12 “(1) *the original recipient; or*

13 “(2) *the entity carrying out the service-learning*
14 *program supported with the assistance.*”.

15 **SEC. 1202. HIGHER EDUCATION PROVISIONS.**

16 *Section 119 (42 U.S.C. 12561) is redesignated as sec-*
17 *tion 117 and amended—*

18 (1) *in subsection (a), by inserting after “commu-*

20 *ice-learning”;*

21 (2) *in subsection (b)—*

22 (A) *in the matter preceding paragraph (1),*
23 *by striking “combination” and inserting “con-*
24 *sortia”;*

25 (B) *in paragraph (1)—*

1 (i) in subparagraph (A), by striking
2 “and” at the end;

3 (ii) in subparagraph (B), by adding
4 “and” at the end; and

5 (iii) by adding at the end the fol-
6 lowing:

7 “(C) may coordinate with service-learning
8 curricula being offered in the academic curricula
9 at the institution of higher education or at one
10 or more members of the consortia;”;

11 (3) in subsection (b)(3)—

12 (A) in the matter preceding subparagraph
13 (A), by striking “teachers at the elementary, sec-
14 ondary, and postsecondary levels” and inserting
15 “institutions of higher education and their fac-
16 ulty”;

17 (B) in subparagraph (A), by striking “edu-
18 cation of the institution; and” and inserting
19 “curricula of the institution to strengthen the in-
20 structional capacity of service-learning at the el-
21 ementary and secondary levels;”;

22 (C) by redesignating subparagraph (B) as
23 subparagraph (E); and

24 (D) by inserting after subparagraph (A) the
25 following:

1 “(B) including service-learning as a key
2 component of the health professionals curricula,
3 including nursing, pre-medicine, medicine, and
4 dentistry curricula of the institution;

5 “(C) including service-learning as a key
6 component of the criminal justice professionals
7 curricula of the institution;

8 “(D) including service-learning as a key
9 component of the public policy and public ad-
10 ministration curricula of the institution; and”;

11 (4) by striking subsections (c), (d), (e), and (g);

12 (5) by redesignating subsection (f) as (i); and

13 (6) by inserting after subsection (b) the fol-
14 lowing:

15 “(c) *SPECIAL CONSIDERATION.*—To the extent prac-
16 ticable, the Corporation shall give special consideration to
17 applications submitted by predominantly Black institu-
18 tions, *Historically Black Colleges and Universities, His-*
19 *panic-serving institutions, and Tribal Colleges and Univer-*
20 *sities.*

21 “(d) *FEDERAL, STATE, AND LOCAL CONTRIBUTIONS.*—

22 “(1) *FEDERAL SHARE.*—

23 “(A) *IN GENERAL.*—The Federal share of
24 the cost of carrying out a program for which a

1 *grant is made under this part may not exceed 50*
2 *percent of the total cost of the program.*

3 “(B) *NON-FEDERAL CONTRIBUTION.*—*In*
4 *providing for the remaining share of the cost of*
5 *carrying out such a program, each recipient of*
6 *a grant under this part—*

7 “(i) *shall provide for such share*
8 *through a payment in cash or in kind, fair-*
9 *ly evaluated, including facilities, equip-*
10 *ment, or services; and*

11 “(ii) *may provide for such share*
12 *through State sources or local sources, in-*
13 *cluding private funds or donated services.*

14 “(2) *WAIVER.*—*The Chief Executive Officer may*
15 *wave the requirements of paragraph (1) in whole or*
16 *in part with respect to any such program for any fis-*
17 *cal year if the Corporation determines that such a*

20 “(e) *APPLICATION FOR GRANT.*—

21 “(1) *SUBMISSION.*—*To receive a grant or enter*
22 *into a contract under this part, an applicant shall*
23 *prepare, submit to the Corporation, and obtain ap-*
24 *proval of, an application at such time, in such man-*
25 *ner, and containing such information and assurances*

1 *as the Corporation may reasonably require. In re-*
2 *questing applications for assistance under this part,*
3 *the Corporation shall specify such required informa-*
4 *tion and assurances.*

5 “(2) *CONTENTS.*—*An application submitted*
6 *under paragraph (1) shall contain, at a minimum—*

7 “(A) *assurances that—*

8 “(i) *prior to the placement of a partic-*
9 *ipant, the applicant will consult with the*
10 *appropriate local labor organization, if*
11 *any, representing employees in the area who*
12 *are engaged in the same or similar work as*
13 *that proposed to be carried out by such pro-*
14 *gram, to prevent the displacement and pro-*
15 *tect the rights of such employees; and*

16 “(ii) *the applicant will comply with*
17 *the nonduplication and nondisplacement*
18 *provisions of section 177 and the grievance*
19 *procedures required by section 176; and*

20 “(B) *such other assurances as the Chief Ex-*
21 *ecutive Officer may reasonably require.*

22 “(f) *PRIORITY.*—*In making grants and entering into*
23 *contracts under subsection (b), the Corporation shall give*
24 *priority to applicants or institutions that submit applica-*
25 *tions containing proposals that—*

1 “(1) demonstrate the commitment of the institu-
2 tion of higher education, other than by demonstrating
3 the commitment of the students, to supporting the
4 community service projects carried out under the pro-
5 gram;

6 “(2) specify the manner in which the institution
7 will promote faculty, administration, and staff par-
8 ticipation in the community service projects;

9 “(3) specify the manner in which the institution
10 will provide service to the community through orga-
11 nized programs, including, where appropriate, clin-
12 ical programs for students in professional schools and
13 colleges;

14 “(4) describe any partnership that will partici-
15 pate in the community service projects, such as a
16 partnership comprised of—

17 “(A) the institution;

18 “(B)(i) a community-based agency;

19 “(ii) a local government agency; or

20 “(iii) a non-profit entity that serves or in-
21 volves school-age youth, older adults, or low-in-
22 come communities; and

23 “(C)(i) a student organization;

24 “(ii) a department of the institution; or

1 “(iii) a group of faculty comprised of dif-
2 ferent departments, schools, or colleges at the in-
3 stitution;

4 “(5) demonstrate community involvement in the
5 development of the proposal;

6 “(6) describe research on effective strategies and
7 methods to improve service utilized in the design of
8 the project;

9 “(7) specify that the institution will use such as-
10 sistance to strengthen the service infrastructure in in-
11 stitutions of higher education; or

12 “(8) with respect to projects involving delivery of
13 services, specify projects that involve leadership devel-
14 opment of school aged youth.

15 “(g) *DEFINITION.*—Notwithstanding section 101, as
16 used in this part, the term ‘student’ means an individual
17 who is enrolled in an institution of higher education on
18 a full- or part-time basis.

19 “(h) *FEDERAL WORK-STUDY.*—To be eligible for as-
20 sistance under this part, an institution of higher education
21 must demonstrate that it meets the minimum requirements
22 under section 443(b)(2)(B) of the Higher Education Act of
23 1965 (42 U.S.C. 2753(b)(2)(B)) relating to the participa-
24 tion of Federal Work-Study students in community service

1 activities, or has received a waiver of those requirements
2 from the Secretary of Education.”.

3 **SEC. 1203. INNOVATIVE PROGRAMS AND RESEARCH.**

4 Subtitle B of title I (42 U.S.C. 12521 et seq.) is further
5 amended by adding after part II the following new part:

6 **“PART III—INNOVATIVE SERVICE-LEARNING**
7 **PROGRAMS AND RESEARCH**

8 **“SEC. 118. INNOVATIVE DEMONSTRATION SERVICE-LEARN-**
9 **ING PROGRAMS AND RESEARCH.**

10 “(a) *IN GENERAL.*—From the amounts appropriated
11 to carry out this part for a fiscal year, the Corporation
12 may make grants and fixed amount grants under subsection
13 (f) with eligible entities for activities described in subsection
14 (c).

15 “(b) *ELIGIBLE ENTITIES DEFINED.*—For purposes of
16 this part, the term ‘eligible entity’ means a State education
17 agency, a State commission, a Territory, an Indian tribe,
18 an institution of higher education, a public or private non-
19 profit organization, or a consortia of such entities, where
20 a consortia of two or more such entities may also include
21 a for-profit organization.

22 “(c) *AUTHORIZED ACTIVITIES.*—Funds under this
23 part may be used to—

24 “(1) integrate service-learning programs into the
25 science, technology, engineering, and mathematics

1 *(STEM) curricula at the elementary, secondary, or*
2 *post-secondary and post-baccalaureate levels in co-*
3 *ordination with practicing or retired STEM profes-*
4 *sionals;*

5 *“(2) involve students in service-learning pro-*
6 *grams focusing on energy conservation in their com-*
7 *munity, including conducting educational outreach*
8 *on energy conservation and working to improve en-*
9 *ergy efficiency in low income housing and in public*
10 *spaces;*

11 *“(3) involve students in service-learning projects*
12 *in emergency and disaster preparedness;*

13 *“(4) involve students in service-learning projects*
14 *aimed at improving access to and obtaining the bene-*
15 *fits from computers and other emerging technologies,*
16 *including in low income or rural communities, senior*
17 *centers and communities, schools, libraries, and other*
18 *public spaces;*

19 *“(5) involve high school age youth in the men-*
20 *toring of middle school youth while involving all par-*
21 *ticipants in service-learning to seek to meet unmet*
22 *human, educational, environmental, public safety, or*
23 *emergency disaster preparedness needs in their com-*
24 *munity;*

1 “(6) *conduct research and evaluations on service-*
2 *learning, including service-learning in middle schools,*
3 *and disseminate such research and evaluations wide-*
4 *ly;*

5 “(7) *conduct innovative and creative activities*
6 *as described in section 111(a); and*

7 “(8) *carry out any other innovative service-*
8 *learning programs or research that the Corporation*
9 *considers appropriate.*

10 “(d) *PRIORITY.—Priority shall be given to programs*
11 *that—*

12 “(1) *involve students and community stake-*
13 *holders in the design and implementation of the serv-*
14 *ice-learning program;*

15 “(2) *implement service-learning programs in*
16 *low-income or rural communities; and*

17 “(3) *utilize adult volunteers, including tapping*
18 *the resource of retired and retiring adults, in the*
19 *planning and implementation of the service-learning*
20 *programs.*

21 “(e) *REQUIREMENTS.—*

22 “(1) *THREE-YEAR TERM.—Each program funded*
23 *under this part shall be carried out over a period of*
24 *three years, including one planning year and two ad-*
25 *ditional grant years, with a 1-year extension possible,*

1 *if the program meets performance measures developed*
2 *in accordance with section 179(a) and any other cri-*
3 *teria determined by the Corporation.*

4 “(2) *ENCOURAGEMENT.*—*Each program funded*
5 *under this part is encouraged to collaborate with*
6 *other Learn and Serve programs, AmeriCorps,*
7 *VISTA, and the National Senior Service Corps.*

8 “(3) *EVALUATION.*—*Upon completion of the pro-*
9 *gram, the Corporation shall conduct an independent*
10 *evaluation of the program and widely disseminate the*
11 *results to the service community through multiple*
12 *channels, including the Corporation’s Resource Center*
13 *or a clearinghouse of effective strategies and rec-*
14 *ommendations for improvement.*

15 “(f) *FIXED AMOUNT GRANTS.*—

16 “(1) *GENERAL.*—*For purposes of subsection (a),*
17 *and subject to the limitations in this subsection, the*
18 *Corporation may, upon making a determination de-*
19 *scribed in paragraph (2), approve a fixed amount*
20 *grant that is not subject to the Office of Management*
21 *and Budget cost principles and related financial rec-*
22 *ordkeeping requirements.*

23 “(2) *DETERMINATION.*—*Before approving a fixed*
24 *amount grant, the Corporation must determine*
25 *that—*

1 “(A) *the reasonable and necessary costs of*
2 *carrying out the terms of the grant significantly*
3 *exceed the amount of assistance provided by the*
4 *Corporation; or*

5 “(B) *based on the nature or design of the*
6 *grant, any assistance provided by the Corpora-*
7 *tion can be reasonably presumed to be expended*
8 *on reasonable and necessary costs.*

9 “(3) *MATCHING FUNDS.—*

10 “(A) *IN GENERAL.—The Federal share of*
11 *the cost of carrying out a program for which a*
12 *grant is made under this part may not exceed 50*
13 *percent of the total cost of the program.*

14 “(B) *NON-FEDERAL CONTRIBUTION.—In*
15 *providing for the remaining share of the cost of*
16 *carrying out such a program, each recipient of*
17 *a grant under this part—*

18 “(i) *shall provide for such share*
19 *through a payment in cash or in kind, fair-*
20 *ly evaluated, including facilities, equip-*
21 *ment, or services; and*

22 “(ii) *may provide for such share*
23 *through State sources or local sources, in-*
24 *cluding private funds or donated services.*

1 “(g) *APPLICATIONS*.—To be eligible to carry out a pro-

3 the Corporation, and obtain approval of, an application at
4 such time and in such manner as the Chief Executive Offi-
5 cer may reasonably require.”.

20 (i) *in the first sentence by striking “by*
21 *the agency.” and inserting “by the agency,*
22 *including programs under the Public Lands*
23 *Corps and Urban Youth Corps as described*

2 *outreach, and recruitment for programs receiving as-*
3 *sistance under the national service laws;*

4 *“(8) to collaborate with the training and tech-*
5 *nical assistance programs described in subtitle J and*
6 *in appropriate paragraphs of section 198E(b);*

7 *“(9) to coordinate the clearinghouses described in*
8 *section 198E; and*

9 *“(10) to coordinate with entities receiving funds*
10 *under section 198E(b)(11) in establishing the Reserve*
11 *Corps for alumni of the national service programs to*
12 *serve in emergencies, disasters, and other times of na-*
13 *tional need.*

14 *“(c) COLLABORATION.—The duties described in sub-*
15 *section (b) shall be carried out in collaboration with the*
16 *State Commissions.*

17 *“(d) AUTHORITY TO CONTRACT WITH A BUSINESS.—*
18 *The Corporation may, through contracts or cooperative*
19 *agreements, carry out the marketing duties described in*

1 “(A) *COMPONENTS OF PROGRAMS.*—Such
2 *programs may include life skills training, em-*
3 *ployment training, educational counseling, pro-*
4 *gram to complete a high-school diploma or GED,*
5 *counseling, or a mentoring relationship with an*
6 *adult volunteer.*

7 “(B) *PRIORITY.*—Priority shall be given to
8 *programs that engage retirees to serve as men-*
9 *tors.*

10 “(2) *PROGRAMS FOCUSED ON LEARNING AND*
