1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Civil War Battlefield*
 5 *Preservation Act of 2008”.*

6 **SEC. 2. AUTHORIZATION EXTENDED.**

7 *The American Battlefield Protection Act of 1996 (16*
 8 *U.S.C. 469k) is amended—*

9 *(1) in subsection (d)(7)(A), by striking “fiscal*
 10 *years 2004 through 2008” and inserting “fiscal years*
 11 *2009 through 2013”; and*

12 *(2) by striking subsection (e).*
