## A BILL

To expand the boundaries of the Wallkill National Wildlife Refuge located in Sussex county, New Jersey, and to authorize appropriations for the acquisition of lands and waters located within such expanded boundaries.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. EXPANSION OF WALLKILL NATIONAL WILDLIFE

REFUGE.

(a) EXPANSION.—The boundaries of the Wallkill National Wildlife Refuge, located in Sussex county, New Jersey, are expanded to include the approximately \_\_\_\_\_ acres

of land (including any water and interest in the land) de-

2	entitled "", dated "", and on file in the of-
3	fice of the Director of the United States Fish and Wildlife
4	Service.
5	(b) BOUNDARY REVISIONS.—The Secretary of the In-
6	terior may make such minor modifications to the boundary
7	of the Refuge as the Director determines to be appropriate
8	to—
9	(1) achieve the goals of the United States Fish
10	and Wildlife Service relating to the Refuge; or
11	(2) facilitate the acquisition of property within
12	the Refuge.
13	(c) Availability of Map.—
14	(1) In general.—The Director shall maintain
15	the map referred to in subsection (a) available for
16	inspection in an appropriate office of the United
17	States Fish and Wildlife Service, as determined by
18	the Secretary.
19	(2) Notice.—As soon as practicable after the
20	date of enactment of this Act, the Secretary shall
21	publish in the Federal Register and any publication
22	of local circulation in the area of the Refuge notice
23	of the availability of the map.
24	(d) Authorization of Appropriations.—

1	(1) In general.—To acquire the land referred
2	to in subsection (a) there is authorized to be appro-
3	priated to the Secretary \$10,000,000.
4	(2) Inclusion in Refuge.—Any land, water,
5	or interest acquired by the Secretary pursuant to
6	this section shall—
7	(A) become part of the Refuge; and
8	(B) be administered in accordance with ap-
9	plicable law.
10	(e) Definitions.—In this section:
11	(1) Director.—The term "Director" means
12	the Director of the United States Fish and Wildlife
13	Service.
14	(2) Refuge.—The term "Refuge" means the
15	Wallkill National Wildlife Refuge.
16	(3) Secretary.—The term "Secretary" means
17	the Secretary of the Interior
