of Minnesota, and Mr. KAGEN) introduced the following bill; which was  
referred to the Committee on Veterans' Affairs

## A BILL

To amend title 38, United States Code, to improve services  
for veterans residing in rural areas.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Rural Veterans Serv-  
5       ices Outreach and Training Act”.

6       **SEC. 2. DEFINITION OF OUTREACH.**

7        Section 101 of title 38, United States Code, is  
8       amended by adding at the end the following new para-  
9       graph:

1                   “(34) The term ‘outreach’ means the act or  
2                   process of reaching out in a systematic manner to  
3                   proactively provide information, services, and bene-  
4                   fits counseling to veterans, and to the spouses, chil-  
5                   dren, and parents of veterans, who may be eligible  
6                   to receive benefits under the laws administered by  
7                   the Secretary, and to ensure that such individuals  
8                   are fully informed about, and assisted in applying  
9                   for, any benefits and programs under such laws.”.

10 SEC. 3. DEPARTMENT OF VETERANS AFFAIRS GRANT PRO-  
11 GRAM FOR RURAL COUNTY VETERAN SERV-  
12 ICE OFFICERS.

13 (a) GRANTS.—Chapter 5 of title 38, United States  
14 Code, is amended by inserting after section 531 the fol-  
15 lowing new section:

16       **“§ 532. Grants to assist certain rural counties in em-**  
17                   **ploying county veteran service officers;**  
18                   **professional qualifications**

19       “(a) PURPOSE.—The purpose of this section is to im-  
20 prove outreach and assistance to veterans, and to the  
21 spouses, children, and parents of veterans, who may be  
22 eligible to receive veterans’ or veterans-related benefits  
23 and who are residing in rural counties through the train-  
24 ing of rural county veteran service officers.

1       “(b) GRANT PROGRAM.—The Secretary shall carry  
2 out a program to make competitive grants in accordance  
3 with this section to provide financial assistance to State  
4 departments of veteran affairs for the purpose stated in  
5 subsection (a).

6       “(c) AMOUNT OF GRANT.—The amount of a grant  
7 under this section shall be determined by the Secretary,  
8 but may not exceed \$1,000,000.

9       “(d) ELIGIBILITY.—For purposes of this section, a  
10 State is eligible for a grant under this section if it can  
11 demonstrate any of the following:

12       “(1) That it has at least one county, in which  
13 veterans reside, that does not have a county veterans  
14 service officer.

15       “(2) That it has at least one county, in which  
16 veterans reside, that has a county veterans service  
17 officer who performs county veterans service officer  
18 functions on less than a full-time basis and that  
19 county is able to demonstrate a need for additional  
20 services by a county veterans service officer.

21       “(3) That it has at least one county, in which  
22 not fewer than 1,000 veterans reside, that currently  
23 has a full-time county veterans service officer, but  
24 only if the county is able to demonstrate a need for

1 additional services by a county veterans service offi-  
2 cer.

3 “(e) COMPETITION FOR GRANT.—An eligible State  
4 seeking a grant under this section shall submit to the Sec-  
5 retary an application for the grant. The application shall  
6 be in such form and shall contain such information as the  
7 Secretary may require, including information establishing  
8 that the State is an eligible State under this section. From  
9 the applications submitted the Secretary shall approve  
10 those applications that the Secretary determines to be the  
11 most promising in carrying out the purposes of the grant  
12 program. Each State whose application is selected by the  
13 Secretary to receive a grant under the grant program shall  
14 receive funds in an amount determined by the Secretary  
15 under subsection (c). In making such determination, the  
16 Secretary shall take into consideration the amount of the  
17 total appropriation for the grant program, the relative size  
18 of the State’s veteran population, and the funding nec-  
19 essary to improve training and outreach of county veteran  
20 service officers in rural counties. Such funds shall go to  
21 the State department of veterans’ affairs.

22 “(f) REQUIREMENTS FOR STATE RECEIPT OF FED-  
23 ERAL FUNDS.—Each State receiving a grant under this  
24 section shall—

1           “(1) provide to the Secretary information and  
2       assurances that the funds received under the grant  
3       program for the training of county veteran service  
4       officers will go to assist counties described in para-  
5       graph (1), (2), or (3) of subsection (d);

6           “(2) provide an assurance that the State agency  
7       shall match the Federal funds provided under this  
8       section by providing at least 20 percent of the total  
9       cost of the grant program; and

10          “(3) use funds received under this section only  
11       to supplement the amount of funds that would, in  
12       the absence of such Federal funds, be made avail-  
13       able from non-Federal sources for the purposes of  
14       this section, and not to supplant such funds.

15          “(g) COUNTY VETERAN SERVICE OFFICER.—For  
16       purposes of this section, a county veteran service officer  
17       is an employee of a county (regardless of job title) whose  
18       duties include providing to veterans residing in the county  
19       advice and casework services related to benefits provided  
20       under laws administered by the Secretary.

21          “(h) GRANT FREQUENCY.—Grants under this section  
22       shall be made on an annual basis.

23          “(i) AUTHORIZATION OF APPROPRIATIONS.—There  
24       are authorized to be appropriated for the fiscal years 2008

1 through 2011 such sums as may be necessary to carry  
2 out this section.”.

3 (b) CLERICAL AMENDMENT.—The table of sections  
4 at the beginning of such chapter is amended by inserting  
5 after the item relating to section 531 the following new  
6 item:

“532. Grants to assist certain rural counties in employing county veteran serv-  
ice officers; professional qualifications.”.
