A BILL

- 3 SECTION 1. PURPOSE.
- 4 The purpose of this Act is to establish a demonstration
- 5 program to facilitate landscape restoration programs with-
- 6 in those units of the National Park System established by
- 7 statute to preserve and interpret resources associated with
- 8 American military history.

9 SEC. 2. DEMONSTRATION PROGRAM AUTHORIZED.

- 18 (b) Participation.—The Secretary shall permit each
- 19 of the 24 National Battlefields, National Battlefield Parks,

- 21 existence on the date of the enactment of this Act to partici-
- 22 pate in the demonstration program authorized by sub-
- 23 section (a) if the unit has in place, before the date of the
- 24 enactment of this Act, a general management plan, cultural
- 25 landscape plan, or other resources management plan ap-
