 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Port Chicago Naval
 - 5 Magazine National Memorial Enhancement Act of 2007".
 - 6 SEC. 2. PORT CHICAGO NAVAL MAGAZINE NATIONAL ME-
 - 7 **MORIAL.**
 - 8 Section 203 of the Port Chicago National Memorial
 - 9 Act of 1992 (Public Law 102–562; 16 U.S.C. 431; 106
- 10 Stat. 4235) is amended—
- 11 (1) by redesignating subsection (c) as sub-
- section (g);
- 13 (2) by inserting after subsection (b) the fol-
- lowing new subsections:
- 15 "(c) Administration.—The Secretary of the Inte-
- 16 rior shall administer the Port Chicago Naval Magazine
- 17 National Memorial as a unit of the National Park System
- 18 in accordance with this Act and laws generally applicable
- 19 to units of the National Park System, including the Na-
- 20 tional Park Service Organic Act (39 Stat. 535; 16 U.S.C.

- 1 1 et seq.) and the Act of August 21, 1935 (49 Stat. 666;
- 2 16 U.S.C. 461 et seq.).
- 3 "(d) Transfer of Land.—Notwithstanding any
- 4 other provision of law, whenever the Secretary of Defense
- 5 determines that the land depicted within the proposed
- 6 boundary on the map titled 'Port Chicago Naval Magazine
- 7 National Memorial, Proposed Boundary', numbered 018/
- 8 80,001, and dated August 2005, is excess to military
- 9 needs, the Secretary of Defense shall transfer the land,
- 10 which consists of approximately 5 acres, to the administra-
- 11 tive jurisdiction of the Secretary of the Interior, who shall
- 12 administer the property in accordance with subsection (c).
- 13 "(e) Environmental Remediation.—As part of
- 14 the transfer under subsection (d), the Secretary of De-
- 15 fense shall perform, in accordance with the Comprehensive
- 16 Environmental Response, Compensation, and Liability Act
- 17 of 1980 (42 U.S.C. 9601 et seq.) and other applicable
- 18 laws, all environmental remediation actions necessary to
- 19 respond to environmental contamination attributable to
- 20 former military activities on the property.
- 21 "(f) AGREEMENT WITH CITY OF CONCORD AND
- 22 East Bay Regional Park District.—The Secretary of
- 23 the Interior is authorized to enter into an agreement with
- 24 the City of Concord, California, and the East Bay Re-
- 25 gional Park District, to establish and operate a facility

- 1 for visitor orientation and parking, administrative offices,
- 2 and curatorial storage for the Memorial."; and
- 3 (3) in subsection (g), (as redesignated by para-
- 4 graph (1)), by striking "Secretary of the Navy to
- 5 provide public access to the Memorial." and insert-
- 6 ing "Secretary of Defense to provide as much public
- 7 access as possible to the Memorial without inter-
- 8 fering with military needs.".

- 10 It is the sense of Congress that in order to preserve
- 11 the Port Chicago Naval Magazine National Memorial for
- 12 future generations, the Secretary of Defense and the Sec-
- 13 retary of the Interior should work together to—
- 14 (1) repair storm damage to the Port Chicago
- site; and
- 16 (2) develop a process by which future repairs
- and necessary modifications to the site can be
- achieved in as timely and cost-effective a manner as
- possible.
