A BILL

To improve the Operating Fund for public housing of the Department of Housing and Urban Development.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Public Housing Asset*
3 *Management Improvement Act of 2007”.*

4 **SEC. 2. REVISIONS TO ASSET MANAGEMENT RULES AND RE-**
5 **LATED FEES.**

6 (a) *MANAGEMENT AND RELATED FEES.—The Sec-*
7 *retary shall not impose any restriction or limitation on the*
8 *amount of management and related fees with respect to a*
9 *public housing project if the fee is determined to be reason-*
10 *able by the public housing agency, unless such restriction*
11 *or limitation imposed by the Secretary on such fees—*

12 (1) *is determined pursuant to a negotiated rule-*
13 *making which is convened by the Secretary no earlier*
14 *than April 1, 2009, and in accordance with sub-*
15 *chapter III of chapter 5 of title 5, United States Code,*
16 *with representatives from interested parties; and*

17 (2) *is effective only on or after January 1, 2011.*

18 (b) *INCREASE OF THRESHOLD FOR EXEMPTION FROM*
19 *ASSET MANAGEMENT REQUIREMENTS.—Any public hous-*
20 *ing agency that owns or operates fewer than 500 public*
21 *housing units under title I of the United States Housing*
22 *Act of 1937 may elect to be exempt from any asset manage-*
23 *ment requirement imposed by the Secretary.*

1 **SEC. 3. PROHIBITION ON RESTRICTION OF FUNGIBILITY OF**
2 **CAPITAL FUND AMOUNTS.**

3 *The Secretary of Housing and Urban Development*
4 *shall not impose any requirement, regulation, or guideline*
5 *relating to asset management that restricts or limits in any*
6 *way the use by public housing agencies of amounts for Cap-*
7 *ital Fund assistance under section 9(d) of such Act, pursu-*
8 *ant to paragraph (1) or (2) of section 9(g) of the United*
9 *States Housing Act of 1937 (42 U.S.C. 1437g(g)), for costs*
10 *of any central office of a public housing agency.*

11 **SEC. 4. TENANT PARTICIPATION.**

12 *(a) RULE OF CONSTRUCTION.—Neither the require-*
13 *ments of this Act, nor any other requirement, regulation,*
14 *guideline, or other policy or action of the Department of*
15 *Housing and Urban Development relating to public housing*
16 *asset management may be construed to repeal or waive any*
17 *provision of part 964 of title 24 of the Code of Federal Regu-*
18 *lations, regarding tenant participation and tenant oppor-*
19 *tunities in public housing. The Secretary of Housing and*
20 *Urban Development shall ensure that public housing agen-*
21 *cies encourage the reasonable efforts of resident tenant orga-*
22 *nizations to represent their members or the reasonable ef-*
23 *forts of tenants to organize.*

24 *(b) GUIDANCE.—Guidance issued by the Secretary of*
25 *Housing and Urban Development shall encourage partici-*
26 *pation by residents in the implementation of asset manage-*

1 *ment and the development of local policies for such pur-*
2 *poses.*
