## A BILL

To require every Senator and Representative in, and Delegate and Resident Commissioner to, the Congress to obtain copies of the Constitution of the United States of America and distribute them to their staff and require that they all read such document.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “AMERICA Act of  
5 2007: A Modest Effort to Read and Instill the Constitu-  
6 tion Again”.

1 **SEC. 2. SENSE OF CONGRESS.**

2 It is the sense of Congress that since we, as Members  
3 of Congress, swear to uphold the Constitution of the  
4 United States, write laws regarding the powers granted  
5 to the Government, and propose constitutional amend-  
6 ments, we should be required to read this important docu-  
7 ment including its amendments.

8 **SEC. 3. DISTRIBUTION AND READING OF THE CONSTITU-**  
9 **TION.**

10 Within 90 days after the date of enactment of this  
11 Act and during each session of Congress thereafter, every  
12 Member of Congress shall obtain copies of the Constitu-  
13 tion of the United States of America, including all amend-  
14 ments thereto, read such document, and distribute such  
15 document to their personal, committee, and subcommittee  
16 staff and require that each such staffer read such docu-  
17 ment in its entirety at least once during each session of  
18 Congress in which they serve or are so employed after such  
19 date.

20 **SEC. 4. REPORTING REQUIREMENT.**

21 Every Member of Congress and their personal, com-  
22 mittee, and subcommittee staff are required to report in  
23 writing to the Committee on House Administration of the  
24 House of Representatives or the Committee on Rules and  
25 Administration of the Senate, as applicable, the date on  
26 which they complete their annual reading of the Constitu-

1 tion. Each such committee shall publish on its website the  
2 list of the Members of its body who have satisfied their  
3 requirement.

4 **SEC. 5. DEFINITION.**

5       As used in this Act, the term “Member of Congress”  
6 refers to a Senator or Representative in, or a Delegate  
7 or Resident Commissioner to, the Congress.
