1 **SECTION 1. JAMES M. & THOMAS W.L. ASHLEY CUSTOMS**
2 **BUILDING AND UNITED STATES COURT-**
3 **HOUSE.**

4 (a) DESIGNATION.—The Federal building and United
5 States courthouse located at 1716 Spielbusch Avenue in
6 Toledo, Ohio, shall be known as the “James M. & Thomas
7 W.L. Ashley Customs Building and United States Court-
8 house”.

9 (b) REFERENCES.—Any reference in a law, map, reg-
10 ulation, document, paper, or other record of the United
11 States to the Federal building and United States court-
12 house referred to in subsection (a) shall be deemed to be
13 a reference to the “James M. & Thomas W.L. Ashley Cus-
14 toms Building and United States Courthouse”.

15 **SECTION 1. DESIGNATION.**

16 *The United States courthouse located at 1716*
17 *Spielbusch Avenue in Toledo, Ohio, shall be known and des-*
18 *ignated as the “James M. Ashley and Thomas W.L. Ashley*
19 *United States Courthouse”.*

20 **SEC. 2. REFERENCES.**

21 *Any reference in a law, map, regulation, document,*
22 *paper, or other record of the United States to the United*
23 *States courthouse referred to in section 1 shall be deemed*
24 *to be a reference to the “James M. Ashley and Thomas W.L.*
25 *Ashley United States Courthouse”.*

Amend the title so as to read: “A bill to designate the United States courthouse located at 1716 Spielbusch Avenue in Toledo, Ohio, as the ‘James M. Ashley and Thomas W.L. Ashley United States Courthouse’.”.
