A BILL

To improve the availability of benefits for veterans and the surviving spouses of veterans who were exposed while in military service to ionizing radiation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Recognition of Forgot-
- 5 ten Atomic Veterans and their Surviving Spouses Act of
- 6 2007".

1	SEC. 2. IMPROVED ACCESS FOR VETERANS AND SURVIVING
2	SPOUSES TO BENEFITS UNDER RADIATION
3	EXPOSURE COMPENSATION ACT.
4	(a) Identification of Living Atomic Veterans
5	AND SURVIVING SPOUSES OF DECEASED ATOMIC VET-
6	ERANS.—The Attorney General shall—
7	(1) obtain from the files of the Operations Of-
8	fice of the Department of Energy in Nevada records
9	showing the identity of all atomic veterans;
10	(2) with respect to each atomic veteran for
11	whom records are obtained under paragraph (1), use
12	the service serial number of that veteran to obtain
13	the veteran's social security number;
14	(3) with respect to each such atomic veteran
15	who is living—
16	(A) use that veteran's social security num-
17	ber to locate the veteran; and
18	(B) advise that veteran of the provisions of
19	the Radiation Exposure Compensation Act, in-
20	cluding the right of the veteran to file a claim
21	under that Act; and
22	(4) with respect to each such atomic veteran
23	who is deceased—
24	(A) use that veteran's social security num-
25	ber to locate the surviving spouse of the veteran
26	(if any); and

- 1 (B) if a surviving spouse is located, advise 2 that surviving spouse of the provisions of the 3 Radiation Exposure Compensation Act, includ-4 ing the right of the surviving spouse to file a
- 5 claim under that Act.
- 6 (b) Assistance in Filing Claims.—The Attorney
- 7 General shall assist any atomic veteran or surviving
- 8 spouse identified under subsection (a)(3) or (a)(4), respec-
- 9 tively, in filing a claim under the Radiation Exposure
- 10 Compensation Act, if the atomic veteran or surviving
- 11 spouse requests such assistance.
- 12 (c) Assitance From Other Agencies.—The heads
- 13 of other Departments and agencies of the United States
- 14 shall assist the Attorney General as necessary to enable
- 15 the Attorney General to carry out the provisions of this
- 16 section, including assistance in providing access to records
- 17 needed for the Attorney General to carry out this section.
- 18 (d) Atomic Veterans.—For purposes of this sec-
- 19 tion, the term "atomic veteran" means a person who while
- 20 serving in the Armed Forces was exposed to ionizing radi-
- 21 ation or fallout from the atmospheric detonation of a nu-
- 22 clear device.

1	SEC. 3. ADDITIONAL CONDITIONS PRESUMED TO BE SERV-
2	ICE-CONNECTED WHEN APPEARING IN RADI-
3	ATION-EXPOSED VETERANS.
4	For purposes of paragraph (1) of section 1112(c) of
5	title 38, United States Code, any disease covered as of
6	the date of the enactment of this Act under section 3.309
7	or 3.311 of title 38 of the Code of Federal Regulations
8	shall be considered to be a disease specified in paragraph
9	(2) of section 1112(c) of title 38, United States Code.
