A BILL

To provide for educational partnerships between science museums and National Laboratories.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Science Museum and
- 5 National Laboratory Partnership Demonstration Act".
- 6 SEC. 2. SCIENCE EDUCATION PARTNERSHIPS.
- 7 (a) AUTHORITY.—The Secretary of Energy is author-
- 8 ized to award on a competitive basis up to 5 grants to
- 9 partnerships for the purposes of—

1	(1) increasing public understanding of the sci-
2	entific work occurring at the National Laboratories;
3	(2) developing exhibits and informal education
4	programs featuring advances in physical sciences;
5	and
6	(3) increasing public understanding of science,
7	technology, engineering, and mathematics dis-
8	ciplines.
9	(b) QUALIFICATIONS.—Grants shall be awarded
10	under this section only to partnerships that include science
11	museums, or consortia thereof—
12	(1) serving no fewer than 1,000,000 visitors an-
13	nually; and
14	(2) with an existing partnership with one or
15	more National Laboratories.
16	(c) Grant Allocation.—Science museums or con-
17	sortia thereof may not receive more than 60 percent of
18	a grant award for any fiscal year, with the remaining
19	funds allocated to National Laboratory partners.
20	(d) Definitions.—In this Act—
21	(1) the term "National Laboratory" has the
22	meaning given that term in section 2 of the Energy
23	Policy Act of 2005 (42 U.S.C. 15801);
24	(2) the term "partnership" means as an agree-
25	ment among a science museum (or consortia thereof)

- and one or more Department of Energy National
 Laboratories; and
- 3 (3) the term "science museum" means an ac-4 credited nonprofit museum with a mission to educate 5 and inspire the public about science, scientific ad-6 vancement, and careers in science.
- 7 (e) AUTHORIZATION OF APPROPRIATIONS.—There 8 are authorized to be appropriated to the Secretary of En-
- 9 ergy for carrying out this Act \$20,000,000 for each of

10 the fiscal years 2008, 2009, 2010, and 2011.
