8	(a) In General.—Section 13902(a)(1) of title 49,

12	(2) by redesignating subparagraph (C) as sub-

14	(3) by inserting after subparagraph (B) the fol-

- vated passenger deck located over a baggage com-
- partment.".

- 17 of this Act, the Secretary shall take necessary actions to

- 3 of Justice, respectively, in enforcing the compliance of
- 4 motor carriers of passengers providing transportation by
- 5 an over-the-road bus (as defined in section 13102 of title
- 6 49, United States Code) with the accessibility require-
- 7 ments established by the Secretary under subpart H of
- 8 part 37 of title 49, Code of Federal Regulations, or such
- 9 successor regulations to those accessibility requirements
- 10 as the Secretary may issue. Such memorandum shall rec-
- 11 ognize the Department of Transportation's statutory re-
- 12 sponsibilities as clarified by this Act (including the amend-
- 13 ments made by this Act).
