A BILL

To amend the John F. Kennedy Center Act to authorize appropriations for the John F. Kennedy Center for the Performing Arts, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "John F. Kennedy Cen-
- 3 ter Reauthorization Act of 2007".
- 4 SEC. 2. TECHNICAL AMENDMENT.
- 5 Section 2(a)(2)(J)(ii) of the John F. Kennedy Center
- 6 Act (20 U.S.C. 76h(a)(2)(J)(ii)) is amended by striking
- 7 "Public Works and Transportation" and inserting
- 8 "Transportation and Infrastructure".
- 9 SEC. 3. PHOTOVOLTAIC SYSTEM.
- The John F. Kennedy Center Act (20 U.S.C. 76h et
- 11 seq.) is amended by inserting after section 6 the following:
- 12 "SEC. 7. PHOTOVOLTAIC SYSTEM.
- 13 "(a) In General.—The Board is authorized to
- 14 study, plan, design, engineer, and construct a photovoltaic
- 15 system for the main roof of the John F. Kennedy Center
- 16 for the Performing Arts.
- 17 "(b) Report.—Not later than 60 days before begin-
- 18 ning construction of the photovoltaic system pursuant to
- 19 subsection (a), the Board shall submit a report to the
- 20 Committee on Transportation and Infrastructure of the
- 21 House of Representatives and the Committee on Environ-
- 22 ment and Public Works of the Senate on the feasibility
- 23 and design of the project.".
- 24 SEC. 4. AUTHORIZATION OF APPROPRIATIONS.
- 25 Section 13 of the John F. Kennedy Center Act (20
- 26 U.S.C. 76r) is amended—

- 1 (1) by striking subsections (a) and (b) and in-2 serting the following:
- 3 "(a) Maintenance, Repair, and Security.—
- 4 There are authorized to be appropriated to the Board to
- 5 carry out section 4(a)(1)(H)—
- 6 "(1) \$20,200,000 for fiscal year 2008;
- 7 "(2) \$21,800,000 for fiscal year 2009; and
- 8 "(3) \$22,500,000 for fiscal year 2010.
- 9 "(b) Capital Projects.—There are authorized to
- 10 be appropriated to the Board to carry out subparagraphs
- 11 (F) and (G) of section 4(a)(1)—
- "(1) \$23,150,000 for fiscal year 2008;
- "(2) \$16,000,000 for fiscal year 2009; and
- "(3) \$17,000,000 for fiscal year 2010.".
- 15 (2) by redesignating subsection (d) as sub-
- section (e), and by adding after subsection (c) the
- 17 following:
- 18 "(d) Photovoltaic System.—There are authorized
- 19 to be appropriated to the Board such sums as may be nec-
- 20 essary to carry out section 7, with such sums to remain
- 21 available until expended.".
- 22 SEC. 5. EXISTING AUTHORITIES.
- Nothing in this Act shall be construed to limit or af-
- 24 fect the authority or responsibility of the National Capital
- 25 Planning Commission or the Commission of Fine Arts.
