To amend title 38, United States Code, to make certain improvements to the housing loan benefit program of the Department of Veterans Affairs.

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Department of Vet-
- 5 erans Affairs Loan Guaranty Cost Reduction Act of
- 6 2007".
- 7 SEC. 2. IMPROVEMENTS TO HOUSING LOAN PROGRAM OF
- 8 DEPARTMENT OF VETERANS AFFAIRS.
- 9 (a) Increase in Maximum Guaranty Amount.—
- 10 Section 3703(a)(1)(C) of title 38, United States Code, is

- 1 amended by inserting "125 percent of" after "25 percent
- 2 of".
- 3 (b) Extension of Certain Loan Fee Deter-
- 4 MINATION PERIODS.—Section 3729(b)(2) of title 38,
- 5 United States Code, is amended—
- 6 (1) in subparagraphs (A)(iii) and (iv), (B)(ii),
- 7 (C)(i) and (iii), and (D)(i) and (ii), by striking "Oc-
- 8 tober 1, 2011" each place it appears and inserting
- 9 "October 1, 2017"; and
- 10 (2) in subparagraph (B)(iii) and (iv), by strik-
- ing "October 1, 2013" both places it appears and
- inserting "October 1, 2017".
- 13 (c) Increase in Maximum Guaranty Amount for
- 14 CERTAIN REFINANCED LOANS.—Section 3703
- 15 (a)(1)(A)(IV) of title 38, United States Code, is amended
- 16 by inserting "(5)," after "(3),".
- 17 (d) Decrease in Equity Requirement for Cer-
- 18 TAIN LOANS.—Section 3710(b)(8) is amended by striking
- 19 "90 percent" and inserting "100 percent".
- 20 (e) Limitation on Amount of Fees.—Section
- 21 3729 of title 38, United States Code, is amended by add-
- 22 ing at the end the following new subsection:
- 23 "(d) Limitation on Amount of Fee.—For any
- 24 loan guaranteed, insured, or made in an amount that ex-
- 25 ceeds the Freddie Mac conforming loan limit limitation de-

- 1 termined under section 305(a)(2) of the Federal Home
- 2 Loan Mortgage Corporation Act (12 U.S.C. 1454(a)(2))
- 3 for a single-family residence, as in effect on the date of
- 4 the enactment of the Department of Veterans Affairs
- 5 Loan Guaranty Cost Reduction Act of 2007, the amount
- 6 of the fee collected under this section may not exceed the
- 7 amount of such a fee collected for a loan guaranteed, in-
- 8 sured, or made in an amount equal to such limitation.".
- 9 (f) Increase in Guaranty for Affordable
- 10 Homes.—Section 3703(a)(1) of title 38, United States
- 11 Code, is amended—
- (1) By redesignating subparagraph (C) as sub-
- paragraph (D); and
- 14 (2) by inserting after subparagraph (B) the fol-
- lowing new subparagraph (C):
- 16 "(C)(i) The maximum amount of guaranty entitle-
- 17 ment available to an eligible veteran for a loan in any
- 18 amount to purchase a dwelling to be owned and occupied
- 19 by the veteran as a home, if the dwelling is affordable
- 20 housing (as determined by the Secretary, in consultation
- 21 with the Secretary of Housing and Urban Development
- 22 and the heads of other appropriate agencies) and the vet-
- 23 eran is the first owner-occupant of the dwelling, shall be
- 24 the greater of—

- 1 "(I) the amount of guaranty entitlement avail-
- 2 able to the veteran under subparagraph (A); or
- 3 "(II) 30 percent of the loan.
- 4 "(ii) For the purposes of this subparagraph, the term
- 5 'eligible veteran' means a veteran whose annual income is
- 6 below a maximum income amount, which shall be deter-
- 7 mined by the Secretary.".
- 8 (g) Use of Certain Funds to Reduce Closing
- 9 Costs for Loans Guaranteed for Affordable
- 10 Homes.—Section 3722 of title 38, United States Code,
- 11 is amended—
- 12 (1) by redesignating subsection (e) as sub-
- section (f);
- 14 (2) by inserting after subsection (d) the fol-
- lowing new subsection (e):
- 16 "(e)(1) Amounts deposited into the fund under sub-
- 17 section (c)(2) that are not expended for the purpose of
- 18 guaranteeing loans under this chapter may be used to re-
- 19 duce the closing costs of a loan referred to in section
- 20 3703(a)(1)(C) or 3762 of this title made to a veteran who
- 21 is not indebted to the Federal Government.
- 22 "(2) During the fiscal years 2008 through 2017, the
- 23 total amount available for payments under paragraph (1)
- 24 may not exceed \$14,000,000.

- 1 "(3) For each fiscal year, the Secretary shall deter-
- 2 mine the amount of each payment under paragraph (1)
- 3 by estimating the number of veterans likely to apply to
- 4 receive such a payment. The Secretary shall make such
- 5 payments in the order in which the Secretary receives ap-

6 plications for such payments.".
