AN ACT

To authorize early repayment of obligations to the Bureau of Reclamation within the A&B Irrigation District in the State of Idaho.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Southern Idaho Bu-
- 3 reau of Reclamation Repayment Act of 2007".
- 4 SEC. 2. EARLY REPAYMENT OF A&B IRRIGATION DISTRICT
- 5 CONSTRUCTION COSTS.
- 6 (a) IN GENERAL.—Notwithstanding section 213 of
- 7 the Reclamation Reform Act of 1982 (43 U.S.C. 390mm),
- 8 any landowner within the A&B Irrigation District in the
- 9 State (referred to in this Act as the "District") may repay,
- 10 at any time, the construction costs of District project fa-
- 11 cilities that are allocated to land of the landowner within
- 12 the District.
- 13 (b) Applicability of Full-Cost Pricing Limita-
- 14 TIONS.—On discharge, in full, of the obligation for repay-
- 15 ment of all construction costs described in subsection (a)
- 16 that are allocated to each parcel of land of the landowner
- 17 in the District, the parcels of land shall not be subject
- 18 to the ownership and full-cost pricing limitations under
- 19 Federal reclamation law (the Act of June 17, 1902 (32)
- 20 Stat. 388, chapter 1093), and Acts supplemental to and
- 21 amendatory of that Act (43 U.S.C. 371 et seq.), including
- 22 the Reclamation Reform Act of 1982 (13 U.S.C. 390aa
- 23 et seq.).
- (c) CERTIFICATION.—On request of a landowner that
- 25 has repaid, in full, the construction costs described in sub-
- 26 section (a), the Secretary of the Interior shall provide to

- 1 the landowner a certificate described in section 213(b)(1)
- 2 of the Reclamation Reform Act of 1982 (43 U.S.C.
- 3 390 mm(b)(1).
- 4 (d) Effect.—Nothing in this Act—
- 5 (1) modifies any contractual rights under, or
- 6 amends or reopens, the reclamation contract between
- 7 the District and the United States; or
- 8 (2) modifies any rights, obligations, or relation-
- 9 ships between the District and landowners in the
- 10 District under Idaho State law.
