Mr. HUNTER introduced the following bill; which was referred to the
Committee on the Judiciary

A BILL

For the relief of Fouad Yousef Hakim Mansour and Saheir
Gamil Shaker Mansour.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR FOUAD**

4 **YOUSEF HAKIM MANSOUR AND SAHEIR**

5 **GAMIL SHAKER MANSOUR.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)
7 and (b) of section 201 of the Immigration and Nationality
8 Act, Fouad Yousef Hakim Mansour and Saheir Gamil
9 Shaker Mansour shall each be eligible for issuance of an
10 immigrant visa or for adjustment of status to that of an

1 alien lawfully admitted for permanent residence upon fil-
2 ing an application for issuance of an immigrant visa under
3 section 204 of such Act or for adjustment of status to
4 lawful permanent resident.

5 (b) ADJUSTMENT OF STATUS.—If Fouad Yousef
6 Hakim Mansour and Saheir Gamil Shaker Mansour enters
7 the United States before the filing deadline specified in
8 subsection (c), he or she shall be considered to have en-
9 tered and remained lawfully and shall, if otherwise eligible,
10 be eligible for adjustment of status under section 245 of
11 the Immigration and Nationality Act as of the date of the
12 enactment of this Act.

13 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
14 FEES.—Subsections (a) and (b) shall apply only if the ap-
15 plication for issuance of an immigrant visa or the applica-
16 tion for adjustment of status is filed with appropriate fees
17 within 2 years after the date of the enactment of this Act.

18 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—
19 Upon the granting of an immigrant visa or permanent res-
20 idence to Fouad Yousef Hakim Mansour and Saheir Gamil
21 Shaker Mansour, the Secretary of State shall instruct the
22 proper officer to reduce by 2, during the current or next
23 following fiscal year, the total number of immigrant visas
24 that are made available to natives of the country of the
25 aliens' birth under section 203(a) of the Immigration and

1 Nationality Act or, if applicable, the total number of immi-
2 grant visas that are made available to natives of the coun-
3 try of the aliens' birth under section 202(e) of such Act.

4 (e) DENIAL OF PREFERENTIAL IMMIGRATION
5 TREATMENT FOR CERTAIN RELATIVES.—The natural
6 parents, brothers, and sisters of Fouad Yousef Hakim
7 Mansour and Saheir Gamil Shaker Mansour shall not, by
8 virtue of such relationship, be accorded any right, privi-
9 lege, or status under the Immigration and Nationality Act.
