## AN ACT

To reauthorize the African Elephant Conservation Act and  
the Rhinoceros and Tiger Conservation Act of 1994.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Multinational Species  
3 Conservation Funds Reauthorization Act of 2007”.

4 **SEC. 2. REAUTHORIZATION AND AMENDMENT OF AFRICAN**  
5 **ELEPHANT CONSERVATION ACT.**

6 (a) NOTICE OF APPROVAL OF PROJECT PROPOSAL.—  
7 Section 2101(c) of the African Elephant Conservation Act  
8 (16 U.S.C. 4211(c)) is amended by striking “and to each  
9 country within which the project is proposed to be con-  
10 ducted”.

11 (b) ADMINISTRATIVE EXPENSES.—Section 2306(b)  
12 of the African Elephant Conservation Act (16 U.S.C.  
13 4245(b)) is amended by striking “\$80,000” and inserting  
14 “\$100,000”.

15 (c) AUTHORIZATION OF APPROPRIATIONS.—Section  
16 2306(a) of the African Elephant Conservation Act (16  
17 U.S.C. 4245(a)) is amended by striking “2001, 2002,  
18 2003, 2004, 2005, 2006, and 2007” and inserting “2007  
19 through 2012”.

20 **SEC. 3. REAUTHORIZATION AND AMENDMENT OF RHINOC-**  
21 **EROS AND TIGER CONSERVATION ACT OF**  
22 **1994.**

23 (a) NOTICE OF APPROVAL OF PROJECT PROPOSAL.—  
24 Section 5(c) of the Rhinoceros and Tiger Conservation Act  
25 of 1994 (16 U.S.C. 5304(c)) is amended in the third sen-  
26 tence by striking “, to the Administrator, and to each

1 country within which the project is to be conducted” and  
2 inserting “and to the Administrator”.

3 (b) ADMINISTRATIVE EXPENSES.—Section 10(b) of  
4 the Rhinoceros and Tiger Conservation Act of 1994 (16  
5 U.S.C. 5306(b)) is amended by striking “\$80,000” and  
6 inserting “\$100,000”.

7 (c) AUTHORIZATION OF APPROPRIATIONS.—Section  
8 10(a) of the Rhinoceros and Tiger Conservation Act of  
9 1994 (16 U.S.C. 5306(a)) is amended by striking “2001,  
10 2002, 2003, 2004, 2005, 2006, and 2007” and inserting  
11 “2007 through 2012”.
