Mr. BRADY of Pennsylvania introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To amend the Servicemembers Civil Relief Act to enhance the protection of credit ratings of active duty military personnel who are activated for military service.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Heroes Credit
5 Protection Act”.

6 **SEC. 2. PROTECTION OF CREDIT RATINGS OF PERSONS AC-**
7 **TIVATED FOR MILITARY SERVICE.**

8 (a) CREDIT RATING PROTECTION.—

1 (1) IN GENERAL.—The Servicemembers Civil
2 Relief Act (50 U.S.C. App. 501 et seq.) is amended
3 by inserting at the end of title I the following new
4 section:

5 **“SEC. 110. PROTECTION OF CREDIT RATINGS OF PERSONS**
6 **ACTIVATED FOR MILITARY SERVICE.**

7 “(a) REQUIREMENTS OF NOTATION OF DELINQUENT
8 OR SLOW PAYMENT DUE TO MILITARY SERVICE.—Any
9 person or entity engaged in the practice of assembling or
10 evaluating consumer credit information that receives from
11 a creditor a negative report of nonpayment or late pay-
12 ment with respect to a qualifying account of a person in
13 military service shall enter with that negative report a no-
14 tation that the account is delinquent or paid slowly due
15 to military service.

16 “(b) NEGATIVE INFORMATION TO BE DIS-
17 REGARDED.—Any future potential creditor of such person
18 who receives a credit report that includes a notation re-
19 quired by subsection (a) shall disregard any negative in-
20 formation so noted in the credit report.

21 “(c) QUALIFYING ACCOUNTS.—For purposes of this
22 section, a qualifying account is an account that was
23 opened by a person in military service before the date on
24 which that person entered that period of military service,

1 but only with respect to obligations incurred before such
2 date.”.

3 (2) CLERICAL AMENDMENT.—The table of con-
4 tents in section 1(b) of such Act is amended by in-
5 serting after the item relating to section 109 the fol-
6 lowing new item:

“Sec. 110. Protection of credit ratings of persons activated for military serv-
ice.”.

7 (b) EFFECTIVE DATE.—Section 110 of the
8 Servicemembers Civil Relief Act, as added by subsection
9 (a), shall apply with respect to a period of military service
10 (as defined in such Act) that is being performed by a per-
11 son on the date of the enactment of this Act or to which
12 a person is ordered on or after such date.
