## A BILL

To rescind funds appropriated by the Consolidated Appropriations Act, 2008, for the City of Berkeley, California, and any entities located in such city, and to provide that such funds shall be transferred to the Operation and Maintenance, Marine Corps account of the Department of Defense for the purposes of recruiting.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Semper Fi Act”.

5 **SEC. 2. RESCISSION AND TRANSFER OF FUNDS.**

6        (a) RESCISSION OF CERTAIN EARMARKS.—All of the  
7 amounts appropriated by the Consolidated Appropriations  
8 Act, 2008 (Public Law 110–161) and the accompanying  
9 report for congressional directed spending items for the  
10 City of Berkeley, California, or entities located in such city  
11 are hereby rescinded.

12        (b) TRANSFER OF FUNDS TO OPERATION AND MAIN-  
13 TENANCE, MARINE CORPS.—The amounts rescinded  
14 under subsection (a) shall be transferred to the “OPER-  
15 ATION AND MAINTENANCE, MARINE CORPS” account of  
16 the Department of Defense for fiscal year 2008 to be used  
17 for recruiting purposes.

18        (c) CONGRESSIONAL DIRECTED SPENDING ITEM DE-  
19 FINED.—In this section, the term “congressional directed  
20 spending item” has the meaning given such term in para-  
21 graph 5(a) of rule XLIV of the Standing Rules of the Sen-  
22 ate.
