A BILL

To authorize funding for the National Advocacy Center.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TRAINING AT THE NATIONAL ADVOCACY CEN-**
2 **TER.**

3 The National District Attorneys Association may use
4 the services of the National Advocacy Center in Columbia,
5 South Carolina to conduct a national training program for
6 State and local prosecutors for the purpose of improving
7 the professional skills of State and local prosecutors and
8 enhancing the ability of Federal, State, and local prosecu-
9 tors to work together.

10 **SEC. 2. COMPREHENSIVE CONTINUING LEGAL EDUCATION.**

11 The National Advocacy Center in Columbia, South
12 Carolina may provide comprehensive continuing legal edu-
13 cation in the areas of trial practice, substantive legal up-
14 dates, and support staff training.

15 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

16 There are authorized to be appropriated to the Attor-
17 ney General to carry out this Act \$6,500,000 for each of
18 the fiscal years 2009 through 2012 to remain available
19 until expended.

20 **SECTION 1. TRAINING FOR STATE AND LOCAL PROSECU-**
21 **TORS.**

22 *The Attorney General is authorized to award a grant*
23 *to a nonprofit organization (such as the National District*
24 *Attorneys Association) to conduct a national training pro-*
25 *gram for State and local prosecutors for the purpose of im-*
26 *proving the professional skills of State and local prosecutors*

1 *and enhancing the ability of Federal, State, and local pros-*
2 *ecutors to work together.*

3 **SEC. 2. COMPREHENSIVE CONTINUING LEGAL EDUCATION.**

4 *The Attorney General may provide assistance to the*
5 *grantee under section 1 to carry out the training program*
6 *described in such section, including comprehensive con-*
7 *tinuing legal education in the areas of trial practice, sub-*
8 *stantive legal updates, support staff training, and any other*
9 *assistance the Attorney General determines to be appro-*
10 *priate.*

11 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

12 *There are authorized to be appropriated to the Attor-*
13 *ney General to carry out this Act \$6,500,000 for each of*
14 *the fiscal years 2009 through 2012, to remain available*
15 *until expended.*
