A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to reauthorize the pre-disaster hazard mitigation program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pre-Disaster Mitiga-
5 tion Act of 2008”.

6 **SEC. 2. PRE-DISASTER HAZARD MITIGATION.**

7 (a) ALLOCATION OF FUNDS.—Section 203(f) of such
8 Act (42 U.S.C. 5133(f)) is amended to read as follows:

9 “(f) ALLOCATION OF FUNDS.—

1 “(1) BASE AMOUNT.—The amount of financial
2 assistance made available to a State (including
3 amounts made available to local governments of the
4 State) under this section for a fiscal year—

5 “(A) shall be not less than the lesser of—

6 “(i) \$575,000; or

7 “(ii) the amount that is equal to 1.0

8 percent of the total funds appropriated to

9 carry out this section for the fiscal year;

10 and

11 “(B) shall be subject to the criteria speci-

12 fied in subsection (g).

13 “(2) COMPETITIVE PROGRAM.—Other than the

14 amounts described in paragraph (1), financial assist-

15 ance made available to a State (including amounts

16 made available to local governments of the State)

17 under this section shall be awarded on a competitive

18 basis subject to the criteria in subsection (g).

19 “(3) MAXIMUM AMOUNT.—The amount of fi-

20 nancial assistance made available to a State (includ-

21 ing amounts made available to local governments of

22 the State) for a fiscal year shall not exceed 15 per-

23 cent of the total amount of funds appropriated to

24 carry out this section for the fiscal year.”.

1 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
2 203(m) of such Act (42 U.S.C. 5133(m)) is amended to
3 read as follows:

4 “(m) AUTHORIZATION OF APPROPRIATIONS.—There
5 is authorized to be appropriated to carry out this section
6 \$250,000,000 for each of fiscal years 2009, 2010, and
7 2011.”.

8 (c) REFERENCES.—Section 203 of such Act (42
9 U.S.C. 5133) is amended—

10 (1) in the section heading by striking
11 “**PREDISASTER**” and inserting “**PRE-DISASTER**”;

12 (2) in the subsection heading for subsection (i)
13 by striking “PREDISASTER” and inserting “PRE-
14 DISASTER”;

15 (3) by striking “Predisaster” each place it ap-
16 pears and inserting “Pre-Disaster”; and

17 (4) by striking “predisaster” each place it ap-
18 pears and inserting “pre-disaster”.
