A BILL

- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. COMMEMORATIVE WORK TO VETERANS WHO
- 4 SERVED IN KOREA AFTER 1953.
- 5 (a) AUTHORITY TO ESTABLISH COMMEMORATIVE
- 6 Work.—The Korean War Veterans Association may es-
- 7 tablish a commemorative work on Federal land in the Dis-

- 1 trict of Columbia and its environs near the Korean War
- 2 Veterans Memorial to honor members of the Armed
- 3 Forces who have served in Korea since July 28, 1953.
- 4 (b) Compliance With Standards for Commemo-
- 5 RATIVE WORKS.—The commemorative work authorized by
- 6 subsection (a) shall be established in accordance with
- 7 chapter 89 of title 40, United States Code (commonly
- 8 known as the "Commemorative Works Act"), except that
- 9 sections 8903(b) and 8908(c) of title 40, United States
- 10 Code, shall not apply to that commemorative work.
- 11 (c) Use of Federal Funds Prohibited.—Federal
- 12 funds may not be used to pay any expense of the establish-
- 13 ment of the commemorative work authorized by subsection
- 14 (a). The Korean War Veterans Association, shall be solely
- 15 responsible for acceptance of contributions for, and pay-
- 16 ment of the expenses of, the establishment of that com-
- 17 memorative work.
- 18 (d) Deposit of Excess Funds.—If, upon payment
- 19 of all expenses of the establishment of the commemorative
- 20 work authorized by subsection (a) (including the mainte-
- 21 nance and preservation amount provided for in section
- 22 8906(b), of title 40, United States Code), or upon expira-
- 23 tion of the authority for the commemorative work under
- 24 chapter 89 of title 40, United States Code, there remains
- 25 a balance of funds received for the establishment of that

- 1 commemorative work, the Korean War Veterans Associa-
- 2 tion, shall transmit the amount of the balance to the Sec-
- 3 retary of the Treasury for deposit in the account provided
- 4 for in section 8906(b)(1) of such title.
- 5 (e) Definitions.—For the purposes of this section,
- 6 the terms "commemorative work" and "the District of Co-
- 7 lumbia and its environs" have the meanings given to such
- 8 terms in section 8902(a) of title 40, United States Code.
