AN ACT

To direct the Secretary of Health and Human Services to encourage research and carry out an educational campaign with respect to pulmonary hypertension, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Tom Lantos Pul-
3 monary Hypertension Research and Education Act of
4 2008”.

7 **TITLE I—RESEARCH ON**
8 **PULMONARY HYPERTENSION**

9 **SEC. 101. EXPANSION AND INTENSIFICATION OF ACTIVI-**
10 **TIES.**

11 (a) SENSE OF CONGRESS.—It is the sense of the Con-
12 gress that—

13 (1) the Secretary of Health and Human Serv-
14 ices (in this Act referred to as the “Secretary”), act-
15 ing through the Director of the National Institutes
16 of Health and the Director of the National Heart,
17 Lung, and Blood Institute (in this title referred to
18 as the “Institute”), should continue aggressive work
19 on pulmonary hypertension;

1 (2) as part of such work, the Director of the In-
2 stitute should continue research to expand the un-
3 derstanding of the causes of, and to find a cure for,
4 pulmonary hypertension; and

5 (3) activities under paragraph (1) may include
6 conducting and supporting—

7 (A) basic research concerning the etiology
8 and causes of pulmonary hypertension;

9 (B) basic research on the relationship be-
10 tween scleroderma, sickle cell anemia (and other
11 conditions identified by the Director of the In-
12 stitute that can lead to a secondary diagnosis of
13 pulmonary hypertension), and pulmonary hy-
14 pertension;

15 (C) clinical research for the development
16 and evaluation of new treatments for pul-
17 monary hypertension, including the establish-
18 ment of a “Pulmonary Hypertension Clinical
19 Research Network”;

20 (D) support for the training of new clini-
21 cians and investigators with expertise in the
22 pulmonary hypertension; and

23 (E) information and education programs
24 for the general public.

1 (b) BIENNIAL REPORTS.—As part of the biennial re-
2 port made under section 403 of the Public Health Service
3 Act (42 U.S.C. 283), the Secretary shall include informa-
4 tion on the status of pulmonary hypertension research at
5 the National Institutes of Health.

6 **TITLE II—INCREASING AWARE-**
7 **NESS OF PULMONARY HYPER-**
8 **TENSION**

9 **SEC. 201. PROMOTING PUBLIC AWARENESS.**

10 (a) IN GENERAL.—The Secretary, acting through the
11 Director of the Centers for Disease Control and Preven-
12 tion, shall carry out an educational campaign to increase
13 public awareness of pulmonary hypertension. Print, video,
14 and Web-based materials distributed under this program
15 may include—

16 (1) basic information on pulmonary hyper-
17 tension and its symptoms; and

18 (2) information on—

19 (A) the incidence and prevalence of pul-
20 monary hypertension;

21 (B) diseases and conditions that can lead
22 to pulmonary hypertension as a secondary diag-
23 nosis;

24 (C) the importance of early diagnosis; and

1 (D) the availability, as medically appro-
2 priate, of a range of treatment options and pul-
3 monary hypertension.

4 (b) DISSEMINATION OF INFORMATION.—The Sec-
5 retary is encouraged to disseminate information under
6 subsection (a) through a cooperative agreement with a na-
7 tional nonprofit entity with expertise in pulmonary hyper-
8 tension.

9 (c) REPORT TO CONGRESS.—Not later than Sep-
10 tember 30, 2009, the Secretary shall report to the Com-
11 mittee on Energy and Commerce of the House of Rep-
12 resentatives, the Committee on Health, Education, Labor,
13 and Pensions of the Senate, and the Committee on Appro-
14 priations of the House of Representatives and the Senate
15 on the status of activities under this section.

16 (d) AUTHORIZATION OF APPROPRIATIONS.—For the
17 purpose of carrying out this section, there is authorized
18 to be appropriated \$2,500,000 for each of fiscal years
19 2009, 2010, and 2011.

20 **SEC. 202. PROMOTING AWARENESS AMONG HEALTH CARE**
21 **PROFESSIONALS.**

22 (a) IN GENERAL.—The Secretary, acting through the
23 Administrator of the Health Resources and Services Ad-
24 ministration and the Director of the Centers for Disease
25 Control and Prevention, shall carry out an educational

1 campaign to increase awareness of pulmonary hyper-
2 tension among health care providers. Print, video, and
3 Web-based materials distributed under this program may
4 include information on—

- 5 (1) the symptoms of pulmonary hypertension;
- 6 (2) the importance of early diagnosis;
- 7 (3) current diagnostic criteria; and
- 8 (4) Food and Drug Administration-approved
9 therapies for the disease.

10 (b) TARGETED HEALTH CARE PROVIDERS.—Health
11 care providers targeted through the campaign under sub-
12 section (a) shall include, but not be limited to, cardiolo-
13 gists, pulmonologists, rheumatologists, primary care phy-
14 sicians, pediatricians, and nurse practitioners

15 (c) DISSEMINATION OF INFORMATION.—The Sec-
16 retary is encouraged to disseminate information under
17 subsection (a) through a cooperative agreement with a na-
18 tional nonprofit entity with expertise in pulmonary hyper-
19 tension.

20 (d) REPORT TO CONGRESS.—Not later than Sep-
21 tember 30, 2009, the Secretary shall report to the Com-
22 mittee on Energy and Commerce of the House of Rep-
23 resentatives, the Committee on Health, Education, Labor,
24 and Pensions of the Senate, and the Committee on Appro-

1 priations of the House of Representatives and the Senate
2 on the status of activities under this section.

3 (e) AUTHORIZATION OF APPROPRIATIONS.—For the
4 purpose of carrying out this section, there is authorized
5 to be appropriated \$2,500,000 for each of fiscal years
6 2009, 2010, and 2011.
